Board Chairman Mark H. LeQuire, M.D., called for a motion to nominate a Vice-Chair of the Alabama State Board of Medical Examiners.




Jane A. Weida, M.D., made a motion that nominations be closed. Gary F. Leung, M.D., seconded the motion.


