be completed online and/or by electronic means; 2) the annual registration, subject to the amended rules, will be implemented January 2012 with a notification to all licensees of the amended rules and of the registration requirements; 3) the initial registrations received will be individually reviewed by members of the Credentials Committee to determine if the registrations should be placed on the agenda for individual review; 4) subsequent to the first annual registration review by the Credentials Committee, future registrations will be reviewed on the staff-level by Pat Enfinger; 5) beginning February 2013, and in February of each subsequent year, the annual registration notification will be generated pursuant to an affirmative answer on the annual medical license renewal application regarding the practice of office based surgery; and 6) annual registration for office based surgery is due by March 1 of each year. The motion was adopted without objection.
