

Skills Request Outside of Protocol

Critical Care Skills Protocol The Credentials Committee recommended that the following amendments be made to the Critical Care Skills Protocol:

1. PAs will no longer be required to request training approval for pleural chest tube removal.
2. The following number of supervised procedures is required for initial certification of the stated skills:
 - a) CVL, remove and replace over guide wire - 5 procedures
 - b) Intra-Aortic Balloon removal - 10 procedures
 - c) Mediastinal Chest Tube removal - 15 procedures
 - d) Pulmonary Artery Catheter removal - 30 procedures
3. For the annual maintenance of all the skills listed in the critical care protocol, half the number of skills that are required for initial certification should be performed annually and the documentation of such should be maintained within the practice location.
4. Half the number of the procedures that are required for certification of central venous line placement, IJ and femoral, and arterial line placement, radial and femoral, may be performed in the simulation lab.
5. The request to train a mid-level practitioner for central venous line remove and replace over guide wire will only be approved for those practitioners who are simultaneously training to perform central venous line placement, IJ and femoral, or who have previously been approved to perform central venous line placement, IJ and femoral.
6. Standard language should be developed for central venous line placement, subclavian.






