



Board Opinion: Regarding the Physician's Duty to Obtain a History and Physical, Delegation of History and Physical to RN The Credentials Committee recommended that the Board adopt the opinion that a physician may delegate to an RN the duty of assisting with obtaining a patient's medical history and vital signs; however, the physician is responsible for reviewing and completing the history and physical examination as part of the physician's responsibility to perform, document and authenticate a complete history and physical examination on a patient.

Continuing Medical Education After consideration of correspondence from the Medical Association of the State of Alabama, the Credentials Committee recommended that Administrative Rule 540-X-14 be amended to require physicians and PAs to annually obtain twenty-five hours of Category 1 continuing medical education without allowance for any prior year carry-over.
