Administrative Rules for Publication

Repeal of Administrative Rules, Chapter 540-X-21, Policy on DATA 2000:

Guidelines for the Treatment of Opioid Addiction in the Medical Office The Credentials Committee recommended that the repeal of Administrative Rules, Chapter 540-X-21, *Policy on DATA 2000: Guidelines for the Treatment of Opioid Addiction in the Medical Office*, be published for public comment in the *Alabama Administrative Monthly*. The motion was adopted without objection.

Other

Act 2022-302: Request for Clarification After consideration of correspondence from the Birmingham Veterans Affairs Health Care System (BVAHCS) requesting the Board's opinion concerning Ala. Code §34-24-704(b)(1)b, the Credentials Committee recommended opining that the "in-person" requirement found at Ala. Code § 34-24-704(b)(1)b may be satisfied by the in-person assistance of personnel licensed by the Board of Medical Examiners or the Board of Nursing at the originating site when the prescriber is evaluating the patient from a distant site using video communication. The motion was adopted without objection.

Administrative Rule, Chapter 540-X-12, Qualified Alabama Controlled Substances Registration Certificate (QACSC) The Credentials Committee recommended the proposal to amend Administrative Rules, Chapter 540-X-12, *Qualified Alabama Controlled Substances Registration Certificate (QACSC)*, be approved and for the rules to be revised accordingly and presented to the Board for approval. The motion was adopted without objection.

Appointment to the Joint Committee for Advanced Practice Nurses The Credentials Committee recommended accepting the resignation of Dick Owens, M.D., from the Advanced Practice Nursing Joint Committee, and approving the appointment of Jane A. Weida, M.D., to fill Dr. Owens' unexpired term through September 30, 2023. The motion was adopted without objection. Jane A. Weida, M.D., recused herself from discussion, determination, and deliberation.

Alabama Medical Cannabis Certification Permit – Initial Draft Application The Credentials Committee recommended that the Alabama Medical Cannabis Certification permit application be approved with the recommended edits. The motion was adopted without objection.




