Administrative Rules for Publication

Administrative Rule 540-X-3-.24, Certificate and Limited License Under Retired Senior Volunteer (RSV) Program

Administrative Rule 540-X-3, Appendix C, Application for a Certificate of Qualification Under the RSV Program The Credentials Committee recommended Administrative Rule 540-X-3-.24, *Certificate and Limited License Under Retired Senior Volunteer (RSV) Program*, and Administrative Rule 540-X-3, Appendix C, *Application for a Certificate of Qualification Under the RSV Program*, be published for public comment in the *Alabama Administrative Monthly*.

Other

Medical Licensure Commission Member Re-Appointment The Credentials Committee recommended the reappointment of Nina Nelson-Garrett, M.D., and Pamela Varner, M.D., to the Medical Licensure Commission be received as information. By unanimous consent, the reappointments were received as information.

Re-Appointment to the Athletic Trainers Advisory Council The Credentials Committee recommended the reappointment of Beverly F. Jordan, M.D., to the Athletic Trainers Advisory Council for a three-year term commencing July 1, 2025, and expiring June 30, 2028, be approved. Beverly F. Jordan, M.D., recused herself from discussion, deliberation, and determination. The motion was adopted without objection.

QACSC and LPSP Protocol Revisions The Credentials Committee recommended that revisions to the Qualified Alabama Controlled Substances (QACSC) and Limited Purpose Schedule II Permit (LPSP) protocols be deferred for development of a standard QA template by Board staff. The motion was adopted without objection.

Request for Declaratory Ruling The Credentials Committee recommended that legal staff be approved to draft a declaratory ruling opining that any business offering the utilization of devices to revise, correct, alter, or treat living tissue is subject to Administrative Rule 540-X-11, *Guidelines for the Use of Lasers and Other Modalities Affecting Living Tissue*. The Committee recommended that the ruling be published on the Board's website, newsletter, and social media accounts. The motion was adopted without objection. The declaratory ruling shall be made a part of these Minutes and shall be attached hereto as Exhibit A.

USMLE Quarterly Update and Board Member and Staff Orientation The Credentials Committee recommended the United States Medical Licensing Examination (USMLE) quarterly update and invitation to the USMLE annual orientation be received as information. By unanimous consent these items were received as information.

ADPH Birthing Center Ruling Amicus Brief The Credentials Committee recommended that legal staff be approved to file a brief in support of the Alabama Department of Public Health's (ADPH) appeal of the Circuit Court's ruling enjoining ADPH from licensing and regulating freestanding birthing centers operating in the midwifery model of care. The motion was adopted without objection.

Physician Wellness Committee The Credentials Committee recommended that George T. Koulianos, M.D., be appointed to the Physician Wellness Committee as Chairman of the committee. The motion was adopted without objection.




