Telemedicine Services Provided to Addiction and Mental Health Patients After consideration of a request for a Board opinion, the Credentials Committee recommended that, pending the drafting and adoption of telemedicine rules, and limited to the facts stated in the request, the Board issue an informal opinion that a subsequent prescriber, of the same or similar specialty as a previous prescriber in the same practice or physician group, may continue to prescribe a controlled substance to a patient based upon an "in-person" examination by the previous prescriber.

The Credentials Committee recommended that legal staff be approved to draft telemedicine rules for Board consideration. The motion was adopted without objection.




