Request for Declaratory Ruling After consideration of correspondence received from Lauren C. DeMoss, Esq., on behalf of a national home health and hospice provider, requesting an opinion regarding certification of home health orders for an Alabama resident that are written by a physician practicing in a contiguous state, the Credentials Committee recommended that the Board opine that an out-of-state physician who resides in a contiguous state, who is not licensed in Alabama, is not approved to certify home health orders for an Alabama resident. However, the Credentials Committee recommended that the Board opine that a home health order signed by a physician as described above can be co-signed by an Alabama licensed physician who reviews and agrees to the order placed by the patient's established out-of-state physician. The Committee recommended that safeguards be delineated in the ruling to mitigate the risk of fraud. The Committee recommended that Wilson Hunter, Esq., General Counsel, be approved to draft the Declaratory Ruling to be presented for final approval at the next meeting of the Board. The motion was adopted without objection.

Insertion by APPs of Non-Tunneled Central Venous Catheter The Credentials Committee recommended that the Critical Care Specialty Protocol be amended to include Central Venous Line (CVL) insertion using a central venous catheter less than 14F with the following requirements:

- a. Limit requests to specific specialties of CRNP (ACNP/AGACNP/ENP), PAs, and collaborating or supervising physician (vascular / nephrology / radiology / pulmonology, general surgeon, or other qualified physician);
- b. Utilize appropriate hospital setting to mitigate possible complications of the procedure;
- c. Minimum of twenty (20) procedures of each requested procedure must be observed and documented prior to submitting request to train;
- d. Minimum of twenty-five (25) procedures of each requested procedure is required for training and until physician determines the APP is competent to perform procedure;
- e. If requesting to train specific specialties of PA/NP for central venous catheter insertion less than 14F, completion of CVL up to 9F is not required to be completed first;
- f. Training may include simulation lab; however, simulation lab procedures will not count towards required training numbers;
- g. Ultrasound guidance required;
- h. Bedside placement allowed;
- i. Femoral and Internal Jugular are the only insertion points approved to be requested. Subclavian insertion is excluded;
- j. Ongoing proficiency of fifteen (15) of each procedure is required for annual maintenance/competency;
- k. Didactic training that includes proper technique of the procedure, use of ultrasound guidance, and sterile technique is required;
- I. Approved only for Level 1 or Level 2 Trauma Center or any Level 3 Trauma Center if a specialty physician is onsite and immediately available.


