Petition for Declaratory Ruling by Alabama Board of Nursing Regarding the Training of Anesthesiologist Assistants After consideration of a request from the Alabama Board of Nursing for a Declaratory Ruling concerning a supervising anesthesiologist delegating to a CRNA, who is under the direction and supervision of the supervising anesthesiologist, the task of teaching, training, educating, or supervising an anesthesiologist assistant (AA) trainee, the Credentials Committee recommended that a ruling be issued stating that a supervising anesthesiologist who has undertaken to provide clinical training to an AA trainee is not legally prohibited from assigning tasks to a CRNA so long as the supervising anesthesiologist directs the CRNA, maintains supervision, and remains responsible for the AA trainee's acts and performances. 


