





ORDER

This matter comes before the Medical Licensure Commission of Alabama upon the expiration of the one hundred eighty-day deadline for Dr. King to take certain actions. The Commission's Order of April 22, 2019 required, as a condition of continued licensure on a probationary status, that Dr. King submit to a neuropsychological evaluation and cause a report of the findings, conclusions, and recommendations to be submitted to the Commission; that he complete two continuing education classes; and that he should pay administrative fines in the amount of fifteen thousand dollars (\$15,000.00), among other things.

The Commission has received no report, payment, or other communication from Dr. King. The Commission's investigator assigned to monitor this case has been unable to contact Dr. King despite repeated attempts, and the Commission's attorney sent an electronic mail inquiry to Dr. King's attorney, but received no response. As required by its Order of April 22, 2019, the Commission finds that Dr. King's probation is revoked by operation of that Order. The license to practice medicine in the state of Alabama issued to Duane Whitby King, M.D. is, therefore, REVOKED.



JOINT SETTLEMENT AGREEMENT

COME NOW, the Complainant, the Alabama State Board of Medical Examiners ("the Board"), through counsel, and the Respondent, Herbert William Jones, M.D., through counsel ("the Parties"), and respectfully submit this Joint Settlement Agreement to the Medical Licensure Commission ("the Commission"), in anticipation of a hearing being held on the appropriate discipline under Medical Licensure Commission Administrative Rule 545-X-5-.03(6)(a). In support, the Parties state as follows:

STIPULATION

1. Dr. Jones admits the allegations made in paragraphs 1-12 in the Administrative Complaint and Petition for Summary Suspension of License and acknowledges that the factual allegations contained in paragraphs 1-12 of the Administrative Complaint constitute grounds for disciplinary action.

2. Dr. Jones stipulates that the factual allegations contained in paragraphs 1-12 of the Administrative Complaint may be used by the Commission to support a finding that he violated Ala. Code §§ 34-24-360(15), having had disciplinary action taken by another state against his license to practice medicine in that state, and (19)a., being unable to practice medicine with reasonable skill and safety to patients by reason of illness, inebriation, excessive use of drugs,

narcotics, alcohol, chemicals, or any other substance, or as a result of any mental or physical condition.

3. Dr. Jones acknowledges the authority of the Commission to exercise jurisdiction in this matter, consents to the imposition of disciplinary sanctions against his license to practice medicine in Alabama based on these facts, and agrees to be bound by the findings of fact, conclusions of law, and terms and conditions of this joint settlement agreement. Dr. Jones waives any further findings of fact and conclusions of law with respect to the above-styled matter and waives any right to appeal from the Joint Settlement Agreement and Commission order.

4. Dr. Jones waives his right to an administrative hearing before the Commission, his right to be represented at such hearing by counsel of his choice and agrees to waive any and all rights to further notice and formal adjudication of charges arising from the facts stated herein.

5. Dr. Jones understands and acknowledges that the Joint Settlement Agreement and Commission Order, if approved and executed by the Commission, shall constitute a public record under the laws of the state of Alabama and will be reported to the National Practitioner Data Bank ("NPDB"), and the Federation of State Medical Boards disciplinary data bank.

6. It is stipulated and agreed between the parties that this Joint Settlement Agreement be submitted to the Commission, and that disciplinary recommendations made by either party shall not be binding on the Commission. If the Respondent elects to withdraw from the Joint Settlement Agreement, any admissions by Dr. Jones in this Joint Settlement Agreement shall not be binding upon him, and the consideration by the Commission of the Joint Settlement Agreement and the settlement memorandums referred to herein shall not be prejudicial to the rights of Dr. Jones to receive a fair and impartial hearing.







- 2) The revocation of Dr. Jones's medical license is STAYED;
- 3) Dr. Jones's medical license is placed on INDEFINITE PROBATION, with the following conditions:
 - a) Dr. Jones shall sign a lifetime Out of State Assistance Agreement with the Alabama Physician Health Program ("APHP") and a Participation Agreement and Monitoring Plan with the Minnesota Health Professionals Services Program ("HPSP");
 - b) Dr. Jones shall comply with all recommendations, terms, conditions, or instructions made by APHP and HPSP under his agreements;
 - c) Dr. Jones shall disclose to APHP all medical evaluation and treatment records requested by APHP and sign all waivers, forms, and documents necessary to effect disclosure;
 - d) Dr. Jones shall fully comply with all terms, limitations, and conditions imposed by the Minnesota Board of Medical Practice (the "Minnesota Board") in its Order of September 14, 2019, which is incorporated by reference as if fully set forth herein, and he shall not exceed or violate them through his practice of medicine in Alabama;
 - e) Any violation of Minnesota Order of September 14, 2019, as determined by the Minnesota Board, shall be deemed a violation under this Order. Dr. Jones shall report to the Commission and to the Board any violation as determined or alleged by the Minnesota Board within forty-eight (48) hours of the violation;
 - f) Dr. Jones shall, within forty-eight (48) hours of issuance, provide the Commission and the Board with a copy of any document issued by the Minnesota Board which

alters the conditions of his license to practice medicine in Minnesota, including, but not limited to, reinstatement of his Minnesota medical license without conditions; and

g) Dr. Jones shall immediately cease the practice of medicine if, at any time, he is advised or directed to do so by APHP and HPSP.


4) Dr. Jones shall pay a fine of five hundred dollars (\$500) each for his violations of Ala. Code §§ 34-24-360(15) (disciplinary action taken by another state) and 34-24-360(19)a. (unable to practice with reasonable skill and safety due to illness, inebriation, or excessive use of a substance), for a total of one thousand dollars (\$1,000) within 30 days of the entry of this Order.

IT IS FURTHER ORDERED that Dr. Jones is required to show complete compliance with this Order before any petition for modification or relief from his probation can be filed. Dr. Jones consents and agrees that the Commission may dismiss any such petition without a hearing if the petition is not accompanied by a report in writing from APHP advocating for the lifting of his probation.

At any time prior to the expiration or termination of this Consent Order, the Alabama Board of Medical Examiners may file a petition for revocation of Dr. Jones's medical license upon a showing of probable cause that Dr. Jones has violated one or more of his terms of probation. Any failure by Dr. Jones to comply with any or all of the conditions imposed by this Consent Order shall be considered a violation of Ala. Code §34-24-360(2). Upon receipt of a petition for revocation, the Commission shall set a hearing and provide notice to Dr. Jones at least twenty (20) days prior to the date set for the hearing. The hearing shall be considered a contested case under

the Alabama Administrative Procedures Act and shall be held in a manner consistent with Medical Licensure Commission Rules 545-X-3-.01, *et seq.*


