ORDER

This matter came before the Medical Licensure Commission of Alabama on November 22, 2019 on an application for licensure to practice medicine or osteopathy in the state of Alabama submitted by Craig C. Oliver, D.O.

On November 22, 2019, the Commission found that the application was due to be and was GRANTED on a probationary basis subject to the following terms of probation:

A. Dr. Oliver shall be restricted to practicing medicine or osteopathy only under the auspices of and under the supervision of attending physicians in the University of South Alabama's Internal Medicine Residency Program.

B. Dr. Oliver shall maintain his contract with the Alabama Physician's Health Program (APHP) in good standing and abide by all of the terms of that contract, including alcohol/drug screenings which APHP may require from time to time.

C. Dr. Oliver shall be monitored and tested by way of a Soberlink device for a period of one year at a frequency to be determined by the MLC in consult with APHP. Such testing shall be additional to the alcohol/drug testing required by Dr. Oliver's contract with APHP, but shall be administered and reviewed by APHP.

D. Dr. Oliver shall execute and, until such time as the MLC lifts the probation of Dr. Oliver's license or Dr. Oliver's license otherwise terminates, Dr. Oliver shall keep in effect a valid consent which complies with the requirements of 42 C.F.R. Part 2. Entered this 15th day of January, 2020.

ORDER

This cause came before the Medical Licensure Commission of Alabama on December 20, 2019 and January 22, 2020. The Commission received an endorsement letter from the Alabama Professionals Health Program (APHP). The Commission finds from the letter submitted by APHP that Dr. Koch has had only one hair or nail test; that having been administered since August, 2019. The Commission's Order of October 7, 2018 required Dr. Koch to successfully complete one year of APHP-directed monitoring, which was required to include hair or nail drug testing at least once every sixty (60) days. The Commission's Order of August 21, 2019 ameliorated the frequency of such hair or nail testing to once every three (3) months. Dr. Koch, therefore, only came into compliance with the Commission's requirements on or about August 21, 2019.

The Commission finds that Dr. Koch has a history of requesting the reinstatement of his license while not being in compliance with the guidelines set out by the Commission. Dr. Koch's request is due to be tabled until Dr. Koch can demonstrate a sufficient history of compliance with the Commission's requirements, which include the drug-testing regimen set out herein and in previous orders.

It is, therefore, ORDERED, that Dr. Koch's request be and is hereby TABLED until such time as Dr. Koch has completed twelve (12) consecutive months of APHP-directed drug and alcohol testing, which testing must include hair or nail testing at least once every ninety (90) days beginning with the first hair or nail drug test administered after December 1, 2019, as well as compliance with the other requirements set out in the Commission's August 21, 2019 Order. Dr. Koch should notify the Commission no earlier than December of 2020 that he has been in compliance for twelve (12) consecutive months.

This cause came before the Medical Licensure Commission of Alabama for hearing on the application for reinstatement, the Agreement dated October 23, 2019 and November 21, 2019, and the Consent Order of the Alabama Board of Medical Examiners dated November 21, 2019. The Commission finds that the application for reinstatement of license submitted by Dr. Chester is due to be and is hereby GRANTED and his license is placed on probation subject to the following terms and conditions of probation:

1. Dr. Chester's license is placed on probation for a term to run concurrent with the federal criminal probation he is serving with the United States Probation Office for the Middle District of Alabama in case number 2:17-CR-511-SLB;

2. Prior to the completion of his probation, Dr. Chester shall attend and successfully complete the Intensive Course in Controlled Substance Prescribing offered by Case Western Reserve University, or a similar course approved by the Board of Medical Examiners;

3. Prior to the completion of his probation, Dr. Chester shall attend and successfully complete an in-person Professional Boundaries and Ethics Course offered by PBI Education, or a similar course approved by the Board of Medical Examiners;

4. Dr. Chester shall abide by all state and federal laws as well as all state and federal administrative rules and regulations related the practice of medicine;

5. Dr. Chester shall comply with all terms of his criminal probation, and any violation, infraction, or sanctions of his criminal probation shall be deemed to be a violation of the terms and conditions of his license probation; and

6. Dr. Chester shall not seek reinstatement of his Alabama Controlled Substance Certificate (ACSC) until he has successfully completed the continuing medical educational requirements set out above.

Dr. Chester shall notify the Commission upon the completion of and release from his federal probation reference herein above.

FINAL ORDER

This cause came before the Medical Licensure Commission of Alabama for hearing on December 20, 2019 on the Administrative Complaint filed by the Alabama Board of Medical Examiners. Due notice having been given, Dr. Ifediba was not present for the hearing and no representative appeared on his behalf. Upon information and belief, Dr. Ifediba was incarcerated at the time of the hearing. Evidence having been submitted and accepted, the Commission makes the following findings of fact:

1. That Dr. Patrick E. Ifediba was convicted by a jury in the United States District Court for the Northern District of Alabama of one count of Conspiracy to Commit Health Care Fraud in violation of 18 U.S.C. § 1349, ten counts of Health Care Fraud, one count of Conspiracy to Distribute a Controlled Substance Outside the Usual Course of Professional Practice or Not for a Legitimate Medical Purpose in violation of 21 U.S.C. § 846, fourteen counts of Distributing or Dispensing a Controlled Substance Outside the Usual Course of Professional Practice or Not for a Legitimate Medical Purpose in violation of 21 U.S.C. § 841(a)(1), one count of Maintaining Premises for the Unlawful Distribution of Controlled

Substances in violation of 21 U.S.C. § 856(a)(1), one count of Conspiracy to Commit Money Laundering in violation of 18 U.S.C. § 1956(h), three counts of Money Laundering in violation of 18 U.S.C. § 1956(a)(1)(B)(i), and four counts of Engaging in Illegal Monetary Transactions in an Amount Greater than ten thousand dollars (\$10,000) in violation of 18 U.S.C. § 1957; that the said jury returned its verdict on July 16, 2019;

2. That, in addition to operating a "pill mill," Dr. Ifediba operated his practice under the guise of an allergy practice as part of a scheme to defraud insurers; that Dr. Ifediba performed allergy skin prick tests on every patient who had insurance without a basis in medical necessity; that Dr. Ifediba instructed his staff to withhold patients' opioid prescriptions if they refused to be tested; that Dr. Ifediba, then, prescribed immunotherapy for every patient who was tested, regardless of the results of the skin tests; that, at Dr. Ifediba's instruction, millions of dollars of fraudulent claims were submitted to health insurers for these unnecessary tests and treatment, for which Dr. Ifediba was paid; and that Dr. Ifediba falsely claimed that the patients' co-pays for these tests and treatment had been collected when they had not.

Based upon these findings, the Commission concludes that Dr. Ifediba:

1. Has been convicted of a felony in violation of § 34-24-360(4) Ala. Code (1975);

2. Has been convicted of a crime or offense which reflects the inability of the practitioner to practice medicine or osteopathy with due regard for the health or safety of his or her patients in violation of § 34-24-360(5);

3. Has been convicted of a violation of federal or state law relating to controlled substances in violation of § 34-24-360(6); and

4. Has been convicted of fraud in filing Medicare or Medicaid claims or in filing claims to third-party payors in violation of § 34-24-360(14).

It is, therefore, ORDERED that the license to practice medicine or osteopathy in the state

of Alabama issued to Patrick E. Ifediba, M.D. be and is hereby REVOKED.

Ndolo, M.D. of the denial of a reinstatement of a certificate of qualification by the Alabama Board of Medical Examiners, the Motion to Dismiss the appeal filed by the Board, the objection by the Board of the inclusion of Dr. Ndolo's Exhibit 10 and the transcript of the July 21, 2017 hearing and the Board's supplement to the record. The matter was submitted to the Commission on brief, and both parties filed briefing documents.

The Record on Appeal

Dr. Ndolo was required by provisions of § 545-X-4-.01 and § 540-X-5-.07 of the Alabama Administrative Code to file the record on appeal. Dr. Ndolo filed a record in this case. The Board objected to two inclusions of that record and supplemented that record. The Board objected to the inclusion in the record of Dr. Ndolo's Exhibit 10, which is correspondence with the Commission setting out information he states that he would have given to the Board had he known they wanted such information. Sections 545-X-4-.01 and 540-X-5-.07 of the Alabama Administrative Code limit what may be included in the record on appeal with a caveat that "the appellant may, upon application, be permitted to supplement the record on appeal, upon a showing that the evidence was newly discovered or was not reasonably available to the appellant at the time of the hearing before the Board." §§ 545-X-4-.01, 540-X-5-.07 Ala. Admin. Code. The Commission finds that Dr. Ndolo's submission of his Exhibit 10 does not meet the parameters of the caveat above. The Board's objection to Exhibit 10 is, therefore, sustained and the document stricken from the record on appeal.

The Board also objected to the inclusion of the transcript of the July 17, 2019 hearing before the Board. The record on appeal, however, includes "[a] verbatim transcript of the proceedings before the Board." §§ 545-X-4-.01, 540-X-5-.07 Ala. Admin. Code. The objection is, therefore, overruled and the transcript shall remain a part of the record on appeal.

The Board sought to supplement the record on appeal with Exhibits 1 through 9, those being the Board's exhibits which the Board considered in its denial. Those documents are properly a part of the record and the motion by the Board to supplement is, therefore, granted. The record on appeal includes the Board's Exhibits 1 through 9.

The Appeal

Upon consideration of the record on appeal in the form set out above and the briefs of the parties, the Medical Licensure Commission of Alabama finds that the denial by the Alabama Board of Medical Examiners of reinstatement of Dr. Ndolo's certificate of qualification is due to be and is hereby AFFIRMED.

Upon the verified Administrative Complaint of the Alabama State Board of Medical Examiners, and pursuant to the authority of Ala. Code §§ 34-24-361(f) and 41-22-19(d), it is the ORDER of the Commission that the license to practice medicine in Alabama, license certificate number MD.25444, of KAREN S. GARDNER MOORE, M.D., be, and the same is hereby, immediately suspended. KAREN S. GARDNER MOORE, M.D., is hereby ORDERED and DIRECTED to surrender the said license certificate to Scott Sides, a duly authorized agent of the Medical Licensure Commission. KAREN S. GARDNER MOORE, M.D., is hereby ORDERED to immediately CEASE and DESIST from the practice of medicine in the State of Alabama until such time as the Administrative Complaint of the Alabama State Board of Medical Examiners shall be heard by the Commission and a decision rendered thereon.

This action is made consistent with the Rules and Regulations of the Board of Medical Examiners and the Medical Licensure Commission and Ala. Code § 34-24-361(f), based upon the request of the Alabama State Board of Medical Examiners upon the Board's finding and certification that the Board presently has evidence in its possession that the continuance in practice of KAREN S. GARDNER MOORE, M.D. may constitute an immediate danger to her patients and/or the public.

It is the further ORDER of the Medical Licensure Commission that the Administrative Complaint of the Alabama State Board of Medical Examiners be, and the same is hereby, set for hearing on the 22 day of 4 pril, 2020, at 9.m., at the offices of the Medical Licensure Commission, 848 Washington Avenue, Montgomery, Alabama.

KAREN S. GARDNER MOORE, M.D., is ORDERED to appear before the Commission at the aforesaid time and date to answer the allegations of the Administrative Complaint filed by the Alabama State Board of Medical Examiners.

It is the further ORDER of the Commission that a copy of the verified Administrative Complaint of the Alabama State Board of Medical Examiners and a copy of this order shall be forthwith served upon KAREN S. GARDNER MOORE, M.D., by personally delivering the same to her at her office or at her residence or such place as she may be found in the State of Alabama, or by certified mail, return receipt requested, to her last known address if she cannot be found in the State of Alabama. The Commission further directs that the service of process shall be made by Scott Sides, who is designated as the duly authorized agent of the Medical Licensure Commission.

It is further ordered that the parties and their attorneys immediately check their calendars for scheduling conflicts. No requests for continuances based upon scheduling conflicts of attorneys or parties will be considered unless such request is made forty-five (45) days prior to the scheduled hearing date.
