



A motion was made by Commissioner Morris to approve full licensure applicants number one through one hundred and two (1-102) for licensure. The motion was approved by unanimous vote.



ORDER

This matter comes before the Medical Licensure Commission of Alabama on the appeal of Joseph N. M. Ndolo, M.D. of the denial of a reinstatement of a certificate of qualification by the Alabama Board of Medical Examiners. This appeal is governed by the provisions of § 545-X-4-.01 and § 540-X-5-.07 of the Alabama Administrative Code. The scope of appeal is limited to consideration of the record before the Board of Medical Examiners. The issue will be scheduled for deliberation and determination at the Commission's November 22, 2019 meeting. It shall be the responsibility of the appellant to ensure that the record on appeal is complete and provided to the Medical Licensure Commission at least twenty (20) days prior to November 22, 2019. Any party wishing to submit a brief shall do so at least ten (10) days prior to the hearing.

ORDER

This cause came before the Commission on the request by Dr. Sharpton for an alternative to the educational or training plans recommended by CPEP, the fulfillment of which is required by the Commission's Order of May 31, 2018. Dr. Sharpton's request is due to be and is hereby denied. In the event that, within sixty (60) days of the date of this order, Dr. Sharpton has not commenced the educational or training plans recommended by CPEP, had a proctor approved by CPEP, and caused to be submitted to the Commission written confirmation by CPEP that Dr. Sharpton's proctor has been approved by them and that Dr. Sharpton has initiated and commenced his recommended training and educational plans, the Commission will deem Dr. Sharpton to be in violation of the terms of his probation. Such violation shall be sufficient grounds for the revocation of probation and the implementation of the penalty set out in the Commission's Order of May 31, 2018: revocation of Dr. Sharpton's license to practice medicine in Alabama.

This matter came before the Medical Licensure Commission of Alabama on the application for licensure from and Certificate of Qualification issued by the Alabama Board of Medical Examiners to Marcus Freeman, M.D. Notice to Dr. Freeman having been duly given, a hearing was held on September 25, 2019, at which Dr. Freeman appeared via video teleconference and testified.

1. That Dr. Freeman completed his application for certificate of qualification by the Alabama Board of Medical Examiners himself, and that he answered questions fourteen, fifteen, sixteen, and seventeen falsely;

2. That Dr. Freeman answered “no” to the question regarding whether his medical training or medical practice had been interrupted or suspended for a period longer than 60 days for any reason; that Dr. Freeman did so knowing that he had two interruptions in his training: one for approximately ten months and one for approximately nine months;

3. That Dr. Freeman answered "no" to the question regarding whether he had ever been placed on academic or disciplinary probation; that Dr. Freeman did so in the knowledge that he was

placed on probation from January, 2015 to April, 2015 by the University of South Florida Morsani Program;

4. That Dr. Freeman answered “no” to the question regarding whether he had ever been disciplined for unprofessional conduct or behavior reasons by a medical school or postgraduate program; that Dr. Freeman did so in the knowledge that he was suspended from clinical privileges with pay on May 17, 2015 at the University of South Florida and his residency contract was not renewed; that Dr. Freeman further did so in the knowledge that he had been placed on performance warning and remediation for professionalism concerns at the Brandon Regional Hospital Program where he was dismissed from the program for failure to successfully remediate professionalism concerns;

5. That Dr. Freeman answered “no” to the question regarding whether he had ever been notified in writing that there were limitations or special requirements imposed on him because of questions of academic or clinical competence, disciplinary problems, or any other reason during his medical education or postgraduate training; that Dr. Freeman did so in the knowledge that he received such written notifications several times while he was at the University of South Florida;

6. That Dr. Freeman was placed on probation at the University of South Florida due to lack of competence in the areas of patient care, medical knowledge, practice based learning and improvement, interpersonal communication, and professionalism; that Dr. Freeman’s clinical privileges were suspended at the University of South Florida for deficiencies in professionalism; that his appeal of the suspension was partially successful, but his residency contract was not renewed; that Dr. Freeman was dismissed from the Brandon Regional Hospital Program after performance warnings and professionalism concerns;

7. That in the verification sent to the Alabama Board of Medical Examiners by Brandon Regional Hospital Program, the Program Director recommended that Dr. Freeman had not demonstrated sufficient competence to enter practice without direct supervision.

Based upon these findings, the Commission concludes that Dr. Freeman committed fraud in applying for or procuring a certificate of qualification to practice medicine or osteopathy or a license to practice medicine or osteopathy in the state of Alabama as set out in § 34-24-360(1) Ala. Code (1975), and that Dr. Freeman is unable to practice medicine or osteopathy with reasonable skill and safety to patients by reason of a demonstrated lack of basic medical knowledge or clinical competency as set out in § 34-24-360(20) Ala. Code (1975).

Notice is hereby given, therefore, the application for licensure to practice medicine or osteopathy in the state of Alabama submitted by Marcus Freeman, M.D. is hereby DENIED.

FINAL ORDER

This cause came before the Medical Licensure Commission of Alabama for hearing on the Administrative Complaint filed by the Alabama Board of Medical Examiners. Notice of the final hearing was duly served on Dr. DiSanto on July 3, 2019, in accordance with the requirements of the Alabama Administrative Procedures and other relevant statutes or rules. A final hearing was had on September 25, 2019, at which Dr. DiSanto did not appear. Upon the evidence and testimony submitted at the final hearing, the Commission makes the following findings of fact:

1. That Dr. DiSanto's license to practice medicine or osteopathy has been disciplined in at least fourteen states outside of Alabama;
2. That in or about November, 2018, Dr. DiSanto submitted to an assessment of his ability to practice medicine by the Center for Personalized Education of Professionals (CPEP) at the direction of the Kentucky Board of Medical Licensure;

3. That CPEP found that Dr. DiSanto “demonstrated significant educational needs in medical knowledge, clinical judgement [sic], and documentation” which warranted remediation.

Among other things, CPEP found that:

a. Dr. DiSanto’s overall knowledge and judgment in the broad scope of general family medicine was outdated and in need of updating; that these needs would best be addressed “through remediation in a formal educational setting (a period in a supervised educational setting such as a residency, fellowship, or residency-like setting)”; that “CPEP does not believe that a CPEP-supervised education plan would be the best remediation option for Dr. DiSanto”;

b. That Dr. DiSanto demonstrated significant educational needs in medical knowledge in several areas, including pulmonology, nephrology/urology, endocrinology/auto-immune disease, hormonal management of men and women, rheumatology, and gerontology;

c. That Dr. DiSanto was unable to correctly describe the recommended management of some conditions, was unaware of the current recommendations for the administration of certain medications or the current recommended screening and/or examination procedures, was unaware of contraindications of some treatments he advocated for in testing or was unaware of side effects of some treatments;

d. That Dr. DiSanto “did not demonstrate the ability to gather information in a logical, organized, and complete fashion”; that his approach to clinical judgment and reasoning was somewhat superficial; that Dr. DiSanto exhibited judgment errors in his management of patients with certain conditions;

e. That Dr. DiSanto’s patient care documentation was poor, his notes incomplete and lacking in sufficient detail, and he failed to provide justification for his assessment and plan;

f. That Dr. DiSanto's cognitive function screen results were below expectations, showing poor outcomes relative to the norms of his age and education level in three of five primary indices.

Based upon these findings, the Commission concludes that Dr. DiSanto:

1. Is unable to practice medicine or osteopathy with reasonable skill and safety to patients by reason of a demonstrated lack of basic medical knowledge or clinical competency as set out in § 34-24-360(20)(a) Ala. Code (1975); and
2. has received disciplinary action in another state against his license to practice medicine or osteopathy based upon acts by the licensee similar to acts described in § 34-24-360.

It is, therefore, ORDERED as follows:

1. That the license to practice medicine or osteopathy issued to Vincent M. DiSanto, D.O. be and is hereby revoked.
2. That Dr. DiSanto is hereby fined one thousand dollars (\$1,000); and
3. That Dr. DiSanto shall pay the administrative costs, fees, and expenses, incurred by the Board of Medical Examiners in the prosecution of this action in accordance with Ala. Admin. Code 545-X-3-.08(11). The Board of Medical Examiners is directed to submit a bill of costs to the Commission within thirty (30) days of this order which shall contain the amounts incurred with the verification provided for in 545-X-3-.08(12). A copy of such submission shall be served on Respondent or his counsel. Respondent shall file any written objections to the bill of costs within ten (10) days of service.

The Medical Licensure Commission of Alabama will consider re-licensure if Dr. DiSanto first successfully completes an ACGME-approved residency program and applies for reinstatement of his license within the time allowed by law.

CONSENT ORDER

This matter is before the Medical Licensure Commission of Alabama (the "Commission") pursuant to an Administrative Complaint filed by the Alabama Board of Medical Examiners (the "Board") on January 25, 2019, and pursuant to a Joint Settlement Agreement entered into by the Board and the Respondent, SHERRI LYNETTE STUDSTILL, M.D., license number MD.33412, on the 25th day of September, 2019. The Commission hereby finds that it has jurisdiction of the Administrative Complaint and the parties hereto, pursuant to Ala. Code § 34-24-361.

In consideration of the Joint Settlement Agreement of the parties, which is incorporated by reference as if set forth fully herein, the Commission hereby finds that the Respondent, SHERRI L. STUDSTILL, M.D., has failed to comply with an order of the Board in violation of Ala. Code § 34-24-360(2).

The Commission concludes, as a matter of law, that the foregoing facts constitute violations of Ala. Code § 34-24-360(2).

Based upon the foregoing findings of fact and conclusions of law, it is the ORDER of the Medical Licensure Commission:


1. That the license to practice medicine of the Respondent, SHERRI L. STUDSTILL,

2. That Dr. Studstill be, and is hereby assessed an administrative fine in the amount of five hundred dollars (\$500) for the violation of Ala. Code § 34-24-360(2). The administrative fine is due and payable to the Medical Licensure Commission on or before December 31, 2019.

**ORDER TEMPORARILY SUSPENDING LICENSE
AND SETTING HEARING**

Upon the verified Administrative Complaint of the Alabama State Board of Medical Examiners, and pursuant to the authority of Ala. Code §§ 34-24-361(f) and 41-22-19(d), it is the ORDER of the Commission that the license to practice medicine in Alabama, license certificate number MD.26107, of THOMAS D. NIELSEN, M.D., be, and the same is hereby, immediately suspended. THOMAS D. NIELSEN, M.D., is hereby ORDERED and DIRECTED to surrender the said license certificate to Roland Johnson, a duly authorized agent of the Medical Licensure Commission. THOMAS D. NIELSEN, M.D., is hereby ORDERED to immediately CEASE and DESIST from the practice of medicine in the State of Alabama until such time as the Administrative Complaint of the Alabama State Board of Medical Examiners shall be heard by the Commission and a decision rendered thereon.

This action is made consistent with the Rules and Regulations of the Board of Medical Examiners and the Medical Licensure Commission and Ala. Code § 34-24-361(f), based upon the request of the Alabama State Board of Medical Examiners upon the Board's finding and certification that the Board presently has evidence in its possession that the continuance in practice

of THOMAS D. NIELSEN, M.D., may constitute an immediate danger to his patients and the public.

It is the further ORDER of the Medical Licensure Commission that the Administrative Complaint of the Alabama State Board of Medical Examiners be, and the same is hereby, set for hearing on the 22nd day of January, 2020, at 9:30 a.m., at the offices of the Medical Licensure Commission, 848 Washington Avenue, Montgomery, Alabama.

THOMAS D. NIELSEN, M.D., is ORDERED to appear before the Commission at the aforesaid time and date to answer the allegations of the Administrative Complaint filed by the Alabama State Board of Medical Examiners.

It is the further ORDER of the Commission that a copy of the verified Administrative Complaint of the Alabama State Board of Medical Examiners and a copy of this order shall be forthwith served upon THOMAS D. NIELSEN, M.D., by personally delivering the same to him at his office or at his residence or such place as he may be found in the State of Alabama, or by certified mail, return receipt requested, to his last known address if he cannot be found in the State of Alabama. The Commission further directs that the service of process shall be made by Roland Johnson, who is designated as the duly authorized agent of the Medical Licensure Commission.

It is further ordered that the parties and their attorneys immediately check their calendars for scheduling conflicts. No requests for continuances based upon scheduling conflicts of attorneys or parties will be considered unless such request is made forty-five (45) days prior to the scheduled hearing date.
