**ORDER TEMPORARILY SUSPENDING LICENSE
AND SETTING HEARING**

Upon the verified Administrative Complaint of the Alabama State Board of Medical Examiners, and pursuant to the authority of Ala. Code § 34-24-361(f) and 41-22-19(d) (2008), it is the ORDER of the Commission that the license to practice medicine, license certificate number MD.13075, of LLOYD ANDREW MANCHIKES, M. D., be, and the same is hereby, immediately suspended. LLOYD ANDREW MANCHIKES, M. D., is hereby ORDERED and DIRECTED to surrender the said license certificate and his Alabama controlled substances registration certificate and all controlled substances of which he has possession to Bob Steelman, a duly authorized agent of the Medical Licensure Commission. LLOYD ANDREW MANCHIKES, M. D., is hereby ORDERED to immediately CEASE and DESIST from the practice of medicine in the State of Alabama until such time as the Administrative Complaint of the Alabama State Board of Medical Examiners shall be heard by the Commission and a decision rendered thereon.

This action is made consistent with the Rules and Regulations of the Board of Medical Examiners and the Medical Licensure Commission and Ala. Code § 34-24-361(f) (2008), based upon the request of the Alabama State Board of Medical Examiners upon the Board's finding and

upon the request of the Alabama State Board of Medical Examiners upon the Board's finding and certification that the Board presently has evidence in its possession that the continuance in practice of LLOYD ANDREW MANCHIKES, M. D., may constitute an immediate danger to his patients and the public.

It is the further ORDER of the Medical Licensure Commission that the Administrative Complaint of the Alabama State Board of Medical Examiners be, and the same is hereby, set for hearing on the 28th day of July, 2024, at 10:00 a.m., at the offices of the Medical Licensure Commission, 848 Washington Avenue, Montgomery, Alabama.

The said LLOYD ANDREW MANCHIKES, M. D., is ORDERED to appear before the Commission at the aforesaid time and date to answer the allegations of the Administrative Complaint filed by the Alabama State Board of Medical Examiners.

It is the further ORDER of the Commission that a copy of the verified Administrative Complaint of the Alabama State Board of Medical Examiners and a copy of this order shall be forthwith served upon the said LLOYD ANDREW MANCHIKES, M. D., by personally delivering the same to him at his office or at his residence or such place as he may be found in the State of Alabama, or overnight courier, signature required, to his last known address if he cannot be found in the State of Alabama. The Commission further directs that the service of process shall be made by Bob Steelman, who is designated as the duly authorized agent of the Medical Licensure Commission.

It is further ordered that the parties and their attorneys immediately check their calendars for scheduling conflicts. **No requests for continuances based upon scheduling conflicts of attorneys or parties will be considered unless such request is made forty-five (45) days prior to the scheduled hearing date.**

This cause comes before the Medical Licensure Commission of Alabama on the request from Dr. Coykendall to amend the previous order in this case to allow for patient care prior to his undergoing a neuropsychiatric evaluation. The Commission finds that the order of February 2, 2021 shall be and is hereby amended and superseded in its entirety as follows, and the license issued to Jeffrey Coykendall, M.D. is restricted as follows:

1. Dr. Coykendall shall not engage in direct patient care without first obtaining written approval from the Commission;
2. Prior to seeking written approval from the Commission and engaging in direct patient care, Dr. Coykendall shall caused to be submitted to the Commission a) a statement from the Alabama Professionals Health Program indicating that Dr. Coykendall is capable of practicing medicine with reasonable skill and safety to patients, b) a statement from Dr. Coykendall's treating psychiatrist indicating that Dr. Coykendall is capable of practicing medicine with reasonable skill and safety to patients, and that he demonstrates executive function necessary to practice medicine, and c) a statement from Dr. Coykendall's licensed professional counselor indicating that Dr. Coykendall is mentally stable and capable of practicing medicine with reasonable skill and safety to patients.

3. Prior to engaging in the practice of medicine, Dr. Coykendall shall obtain a health evaluation from the Alabama Professionals Health Program (APHP);

4. Prior to seeking approval from the Commission for direct patient care, Dr. Coykendall shall obtain a health evaluation from a primary care physician and shall have the physician submit a summary to the Commission;

5. Dr. Coykendall's practice shall be restricted to the personalized assessment and targeted remediation re-entry program administered by St. Vincent's East Family Medicine Residency Program ("St. Vincent's");

6. Dr. Coykendall shall, within one year from the date of this order, undergo a neuropsychological evaluation conducted by the Department of Neurology at the University of Alabama Birmingham (UAB) and shall have UAB submit a report of such evaluation to the Commission; prior to seeking an unrestricted license from the Commission, Dr. Coykendall shall cause to be submitted to the Commission an endorsement by the evaluator of the neuropsychological evaluation referred to immediately above, which endorsement shall state that Dr. Coykendall is capable of practicing medicine with reasonable skill and safety to patients; Dr. Coykendall shall have followed and successfully accomplished any and all recommendations contained in the neuropsychological evaluation report;

7. Dr. Coykendall shall notify the Alabama Board of Medical Examiners and the Medical Licensure Commission of Alabama of any changes of his residence address and any changes in medical practice location or employment and shall provide the reason for such change.

The Commission shall consider lifting the restrictions contained herein upon receipt of proof that Dr. Coykendall has accomplished all of those items listed above as well as an

endorsement by St. Vincent's East Family Medicine Residency Program stating that Dr.

Coykendall is able to practice medicine with reasonable skill and safety to patients.

STIPULATION



Commission of Alabama of the consent order stated herein, and agrees to be bound by the findings of fact, conclusions of law, and terms and conditions stated therein. Dr. Gunn waives any further findings of fact and conclusions of law with respect to the above-styled matter and waives any right to appeal of the joint settlement agreement and consent order.



Based upon the foregoing findings of fact and conclusions of law, it is the ORDER of the Medical Licensure Commission:


1. Respondent's license to practice medicine in Alabama, license number MD. 30614, is REPRIMANDED. The Parties agree to the settlement terms set out below:

JOINT SETTLEMENT AGREEMENT

COME NOW, the Alabama State Board of Medical Examiners ("the Board"), by and through counsel, and KEVIN RAY DIEL, M.D. ("Respondent") and respectfully submit this Joint Settlement Agreement to the Medical Licensure Commission, seeking the entry of the attached Consent Order to resolve the disciplinary charges filed against the Respondent's medical license. In support thereof, the Parties state as follows:

STIPULATION

1. The Respondent was duly licensed to practice medicine or osteopathy in the state of Alabama on January 1, 2011, having been issued license number MD. 30614. Respondent has maintained a license to practice medicine in Alabama since that date, and the Respondent was so licensed at all times relevant to the matters asserted herein.

2. Respondent admits that on or about December 18, 2019, Respondent submitted or caused to be submitted an Alabama medical license renewal application for the year 2020 on which the certification was made that the annual minimum continuing medical education requirement of 25 credits had been met or would be met by December 31, 2019, and the licensee had supporting documents if audited.

3. Respondent admits that, in fact, the required number of continuing medical education credits necessary for renewal of the 2019 license had not been obtained and/or that supporting documentation was not produced; specifically, Respondent obtained four (4) valid credits.

4. Respondent acknowledges and admits that the foregoing facts constitute grounds for the imposition of disciplinary sanctions against the licensee's license to practice medicine or osteopathy in Alabama, specifically, a violation of Ala. Code § 34-24-360(23) and Medical Licensure Commission Rule 545-X-5-.02. Respondent consents and agrees to the entry by the Medical Licensure Commission of Alabama of the consent order reprimanding his license, imposing a two-thousand five hundred dollar (\$2,500) fine, and requiring him to acquire fifty (50) Category 1 or equivalent continuing medical education ("CME") credits on or before December 31, 2021. Respondent further agrees to be bound by the findings of fact, conclusions of law, and terms and conditions stated therein. Respondent waives any further findings of fact and conclusions of law with respect to the above-styled matter and waives any right to appeal of the joint settlement agreement and consent order.

5. It is stipulated and agreed between the parties that this joint settlement agreement and consent order be submitted to the Medical Licensure Commission of Alabama, and that they are subject to the Commission's approval. It is further agreed by the parties that the Medical Licensure Commission shall be permitted to examine and review, prior to approval of this settlement, the records and documents now in the possession of the Board of Medical Examiners concerning the stipulation of facts set forth herein. It is further agreed by the parties that, in the event the Medical Licensure Commission declines to accept this joint settlement agreement and consent order, and requires the Board of Medical Examiners to present testimony and documentary






