A motion was made by Commissioner Alsip with a second by Commissioner Morris to deny the practice plan as presented based upon the length of shifts requested, and to authorize the Chairman, in consultation with the Vice-Chairman, to approve an amended practice plan prior to the next meeting that satisfactorily addresses that issue. Oscar D. Almeida, M.D. The Commission considered an amended request filed by Dr. Almeida for approval of a practice plan to practice telemedicine. A motion was made by Commissioner Alsip with a second by Commissioner Nagrodzki to deny Dr. Almeida's request to practice telemedicine as the current request does not meet the chaperone requirement of the Commission's order of April 21, 2022. Spogmai Wassimi, M.D. The Commission considered a request filed by Dr. Wassimi to lift the restrictions on her license to practice medicine in Alabama. A motion was made by Commissioner Alsip with a second by Commissioner Morris to issue an order granting Dr. Wassimi's request. The motion was approved by unanimous vote. The Commission directed its General Counsel to write a letter to Dr. Boulet thanking him for his comments and informing him of the Commission's discussion.

ORDER

This matter is before the Medical Licensure Commission of Alabama on Respondent's request for approval of a practice plan, submitted via e-mail on December 17, 2022.

Upon review, the Commission concludes that Respondent's proposed practice plan, while improving on his previous proposals, still fails to contain sufficient information and detail from which the Commission can be satisfied that the conditions set forth in Part V of our Findings of Fact and Conclusions of Law of April 21, 2022, can and will be complied with. Specifically, Respondent proposes to dispense with the chaperone requirement altogether in the context of telemedicine. We find this proposal wholly unacceptable. At a minimum, the Commission will require a chaperone—employed and trained in accordance with our April 21, 2022 Order—to observe all female patient encounters via telemedicine either virtually or in person.

Therefore, approval of Respondent's practice plan is denied.

ORDER

On December 1, 2022, the Commission entered an order granting in part, and denying in part, Respondent's "Motion for Stay of Proceedings," filed on November 15, 2022. In that Order, the Commission determined that the hearing in this matter currently scheduled for January 25, 2023, would be continued to May 24, 2023, but only if Respondent "execute[d] an unconditional waiver of the 120-day limitation on the summary suspension of his license to practice medicine in the State of Alabama, using a form that will be provided to his counsel by counsel for the Commission."

The Commission is informed that its General Counsel has provided counsel for the Respondent the form of waiver to be executed on two separate occasions (on December 6 and 16, 2022), but that, as of this date, the executed waiver has not been returned.

Accordingly, it is ORDERED:

- 1. That Respondent shall execute and return the waiver in accordance with the Commission's order of December 1, 2022, no later than 12:00 noon, Central Standard Time, on December 30, 2022.
- 2. If Respondent does not do so, then the hearing in this matter shall be held on January 25, 2023, as originally scheduled.
