



ORDER TEMPORARILY SUSPENDING LICENSE AND SETTING HEARING

Upon the verified Administrative Complaint of the Alabama State Board of Medical Examiners, and pursuant to the authority of Ala. Code § 34-24-361(f) and 41-22-19(d), it is the ORDER of the Commission that the license to practice medicine or osteopathy, license certificate number 28343, of ELIZABETH CAMPBELL KORCZ, M.D., be, and the same is hereby, immediately suspended. ELIZABETH CAMPBELL KORCZ, M.D., is hereby ORDERED and DIRECTED to surrender the said license certificate to Sam Aikens, a duly authorized agent of the Medical Licensure Commission. ELIZABETH CAMPBELL KORCZ, M.D., is hereby ORDERED to immediately CEASE and DESIST from the practice of medicine in the State of Alabama until such time as the Administrative Complaint of the Alabama State Board of Medical Examiners shall be heard by the Commission and a decision rendered thereon.

This action is made consistent with the Rules and Regulations of the Board of Medical Examiners and the Medical Licensure Commission and Ala. Code § 34-24-361(f), based upon the request of the Alabama State Board of Medical Examiners upon the Board's finding and certification that the Board presently has evidence in its possession that the continuance in practice of ELIZABETH CAMPBELL KORCZ, M.D., may constitute an immediate danger to her patients and the public.

It is the further ORDER of the Medical Licensure Commission that the Administrative Complaint of the Alabama State Board of Medical Examiners be, and the same is hereby, set for


hearing on the 2nd day of June, 2022 at 10:00am at the offices of the Medical Licensure Commission, 848 Washington Avenue, Montgomery, Alabama.

ELIZABETH CAMPBELL KORCZ, M.D., is ORDERED to appear before the Commission at the aforesaid time and date to answer the allegations of the Administrative Complaint filed by the Alabama State Board of Medical Examiners.

It is the further ORDER of the Commission that a copy of the verified Administrative Complaint of the Alabama State Board of Medical Examiners and a copy of this order shall be forthwith served upon ELIZABETH CAMPBELL KORCZ, M.D., by personally delivering the same to her at her office or at her residence or such place as she may be found in the State of Alabama, or by certified mail, return receipt requested, to her last known address if she cannot be found in the State of Alabama. The Commission further directs that the service of process shall be made by Jan Aikens, who is designated as the duly authorized agent of the Medical Licensure Commission.

William R. Gordon, Esq., is hereby appointed to act as hearing officer for the Commission. It is further ordered that the parties and their attorneys immediately check their calendars for scheduling conflicts. No requests for continuances based upon scheduling conflicts of attorneys or parties will be considered unless such request is made forty-five (45) days prior to the scheduled hearing date.

CONSENT ORDER


This matter is before the Medical Licensure Commission of Alabama ("the Commission") on the Joint Petition and Stipulation of the Alabama State Board of Medical Examiners and Respondent, GREGORY R. MYRICK, M.D., entered on the 2nd day of March, 2022. The Commission hereby finds that it has jurisdiction over this petition, stipulation, and the parties hereto, pursuant to Ala. Code § 34-24-36 (2010).

In consideration of the Stipulation of the parties, the Commission hereby finds that Respondent, GREGORY R. MYRICK, M.D., has committed acts which violate Ala. Code §§ 34-24-360(2) and (22) (2010). The Commission concludes, as a matter of law, that the foregoing facts constitute violations of Ala. Code §§ 34-24-360(2) and (22) (2010).

Based upon the foregoing findings of fact and conclusions of law, it is the ORDER of the Medical Licensure Commission that Respondent, GREGORY R. MYRICK, M.D., be, and is hereby assessed an administrative fine in the amount of Ten Thousand Dollars (\$10,000.00). The administrative fine is due and payable to the Medical Licensure Commission within thirty (30) days of the date of this Consent Order.

The Medical Licensure Commission retains jurisdiction in this matter for the purpose of entering such further orders and directives as may be required to implement the provisions of this Consent Order.

It is further agreed by the Parties that, in the event the Medical Licensure Commission declines to accept this Stipulation and Consent Order, and requires the Board to present testimony and documentary exhibits at a subsequent hearing, any admissions by Respondent in this Stipulation shall not be binding upon Respondent, and the consideration by the Commission of the Joint Petition, Stipulation and Consent Order and the documentary evidence referred to herein, will not be prejudicial to the right of Respondent to receive a fair and impartial hearing.


6. It is further agreed that Respondent will not seek to disqualify any member of the Medical Licensure Commission from hearing this matter based on that member's consideration of this joint petition.

CONSENT DECREE

This matter comes before the Medical Licensure Commission of Alabama (the "Commission") on the Administrative Complaint filed by the Alabama State Board of Medical Examiners (the "Board") on March 22, 2021. The Board and the Respondent, Michael Sean Dempsey, M.D. ("Respondent"), have entered into a Joint Settlement Agreement (the "Settlement Agreement"), and have asked the Commission to approve the Settlement Agreement and to embody it in the following Consent Decree.

Findings of Fact

1. Respondent has been licensed to practice medicine in the State of Alabama since January 1, 2008, having been issued license number MD.28525.
2. The Administrative Complaint in this matter charges Respondent with reciprocal discipline based on disciplinary action taken by another state (Count One),

making a fraudulent or untrue statement to the Board (Count Two), and unprofessional conduct (Count Three).

3. On or about November 30, 2020, the Georgia Composite Medical Board entered a Public Consent Order finding that Respondent engaged in inappropriate conduct with a patient, in violation of O.C.G.A. § 43-34-8(a)(7), (10), and (15) and Ga. Comp. R. & Regs. 360-3-.02(8). The Georgia order constitutes disciplinary action in another state based on acts that are prohibited under Ala. Code § 34-24-360, and is a violation of Ala. Code § 34-24-360(15).

4. Respondent denies that on or about October 4, 2020, he made a fraudulent or untrue statement to the Board and the Commission when he submitted, or caused to be submitted, an application to renew his Alabama medical license for calendar year 2021 on which he answered "No" to question 6, which asks, "Since your last renewal: Are you the subject of an investigation, or has a formal complaint been filed against you or your license by any licensing Board or state, federal, regulatory or law enforcement agency?" However, Respondent has been advised that the Board likely would be able to meet its burden of proof at a hearing in this matter to show that he was under investigation by the Georgia Composite Medical Board, and that a complaint had been filed against him, at the time he completed his license renewal. The Board acknowledges that Respondent had not received a written complaint or any written documentation from the Georgia Composite Medical Board

at the time of his application on October 4, 2020. Accordingly, to avoid the expense and uncertainty of a hearing, Respondent has consented to the Commission entering an order finding that he violated Ala. Code § 34-24-360(17).

5. On or about June 13, 2020, and continuing through June 14, 2020, Respondent engaged in unprofessional conduct, specifically, inappropriate conduct with a patient at a social gathering, as defined in Ala. Admin. Code R. 545-X-4-.07. In so doing, Respondent violated Ala. Code § 34-24-360(2).

6. Respondent has consented and agreed to the entry of this Consent Decree and has agreed to be bound by the findings of fact, conclusions of law, and terms and conditions stated herein. Respondent has validly waived his right to an administrative hearing before the Commission, his right to be represented by counsel at such hearing, and his rights to further notice and formal adjudication by the Commission of the charges arising from the Administrative Complaint. Respondent has further waived his right to judicial review of this Consent Decree pursuant to the Alabama Administrative Procedure Act, Ala. Code §§ 41-22-1, *et seq.*

7. The Settlement Agreement and this Consent Decree shall constitute public records under the laws of the State of Alabama. The Settlement Agreement and this Consent Decree will be reported by the Board or Commission to the Federal National Practitioner Data Bank ("NPDB") and the Federation of State Medical Boards' ("FSMB") disciplinary data bank.

8. The Board has stipulated and agreed that the terms and conditions of the Settlement Agreement and this Consent Decree constitute a reasonable disposition of the above-captioned matter, and that such disposition adequately protects the public's health and safety.

Conclusions of Law

1. The Commission has jurisdiction over the subject matter of the Administrative Complaint, and over the parties, pursuant to Ala. Code § 34-24-361.

2. The Commission concludes, as a matter of law, that the stipulated facts establish violations of Ala. Code §§ 34-24-360(2), (15), and (17).

Order/Discipline

Based upon the foregoing Findings of Fact and Conclusions of Law, it is the ORDER of the Medical Licensure Commission of Alabama:

1. That Respondent's license to practice medicine in the State of Alabama is REPRIMANDED;

2. That Respondent is ORDERED to comply with the following:

- a. Respondent shall abide by and implement the recommendations made by Pine Grove Behavioral Health;
- b. Respondent shall, at his own cost, enroll in PBI's Medical Chaperone Training Program and implement this training in his medical practice; and
- c. Respondent shall abide by all state and federal laws.

3. That the Board shall monitor Respondent's compliance with the requirements of this Consent Decree.

4. That any violation of the requirements of this Consent Decree, or a new violation of state or federal laws or regulations, may result in the Board filing a petition for revocation of Respondent's medical license.

5. That the Medical Licensure Commission retains jurisdiction for the purpose of entering such other and further orders and directives as may be required to implement the provisions of this Consent Decree.

6. That no administrative costs are assessed against Respondent at this time.
