Re: Administrative Rules Approved for Publication

The Board of Medical Examiners, at its meeting July 17, 2025, approved the following rules to be published for public comment in the *Alabama Administrative Monthly*:

- Administrative Rule 540-X-3-.24, Certificate and Limited License Under Retired Senior Volunteer Program
- Administrative Rule 540-X-3, Appendix C, Application for a Certificate of Qualification Under the Retired Senior Volunteer Program

In the 2025 legislative session, the Legislature passed Act 2025-332, which removed the requirement that a physician volunteer at least 100 hours annually to qualify under the Retired Senior Volunteer Program. The Act is effective Oct. 1, 2025. The amendments to 540-X-3-.24 and Appendix C of Chapter 3 reflect this change with some minor changes to wording that were included in the Act.

With an expected publication date of July 31, 2025, the public comment period ends September 4, 2025. The anticipated effective date November 14, 2025. (due to this being a statute change, our application forms should include these changes on Oct. 1).

# 540-X-3-.24 Certificate And Limited License Under Retired Senior Volunteer Program.

(1)  $\frac{\text{(a)}}{\text{(a)}}$  The State Board of Medical Examiners—may, at its discretion and subject to these rules, may issue a certificate of qualification in behalf of physicians meeting the requirements for participation in the Retired Senior Volunteer Program. The Retired Senior Volunteer Program (RSVP) is created for the purpose of permitting doctors of medicine and doctors of osteopathy who are fully retired from the active practice of medicine to obtain a limited license without cost which would permit the provision of outpatient health care services at established free clinics operated pursuant to the Volunteer Medical Professional Act, \$6-5-6606-5-660, et seq.

(b) (2) Physicians having certificates issued under this section shall comply with the following requirements which are deemed to meet the requirements of Code of Ala. 1975, \$6-5-660, et seqmust limit their practice to the confines of an established free medical clinic, as that term is defined in Ala. Code § 6-5-662, or other non profit organizations or facilities located in Alabama which are approved by the board and which provide outpatient medical care for individuals unable to pay for the care.

1. Physicians receiving a certificate of qualification and license during the time period of January 1 through March 30 of any calendar year shall perform no fewer than 100 hours of voluntary service on or before December 31 of that calendar year;

2. Physicians receiving a certificate of qualification and license during the time period of April 1 through June 30 of any calendar year shall perform no fewer than 75 hours of voluntary service on or before December 31 of that calendar year;

3. Physicians receiving a certificate of qualification and license during the time period of July 1 through September 30 of any calendar year shall perform no fewer than 50 hours of voluntary service on or before December 31 of that calendar year;

4. Physicians receiving a certificate of qualification and license on or after October 1 of any calendar year shall perform no fewer than 25 hours of voluntary service on or before December 31 of that calendar year.

(c) (3) Certificates issued under this section and licenses based thereon shall state on their faces that they the

- <u>certificates</u> are issued under the RSVP and are subject to restrictions.
- (d) (4) Any physician inon whose behalf a certificate of qualification is issued under this section shall be subject to having his or her license suspended or revoked by the Medical Licensure Commission for the same causes or reasons and in the same manner as provided by law in the case of other physicians.
- (e) (5) Certificates of qualification issued under this section shall expire annually and physicians. Physicians may apply to the board for renewal of their certificate, but the board shall have full discretion to accept or reject the application for renewal.
- (2) (a) (6) A physician is eligible to receive a certificate of qualification issued under subsection (a) this rule if he meets the following qualifications are met:
- 1. (a) The applicant currently has or has had a full and unrestricted license to practice medicine in the State of Alabama or in any other state of the United States or the District of Columbia, which license is or was at the time of expiration unrestricted and in good standing with no pending disciplinary actions or investigations at the time of expiration.
- 2.(b) The applicant certifies, on a form prescribed by the board, that he or she is fully retired from the active practice of medicine.
- 3.(c) The applicant is in good health and is not currently undergoing treatment for a physical or mental condition which would impair the individual's ability to practice medicine with reasonable skill and safety to patients.
- $4\cdot (d)$  The applicant certifies, on a form prescribed by the board, that he or she intends to limit his or her medical practice to the provision of outpatient services at an established free medical clinic as that term is defined in Ala. Code § 6-5-662 or such other nonprofit organization or facility that has been approved by the board and that furnishes outpatient medical care to patients unable to pay for itthe care.
- 5.(e) The applicant certifies, on a form prescribed by the board, that his or her license to practice medicine in any state or the District of Columbia has never been revoked, suspended, placed on probation, or otherwise subject to disciplinary action and that the applicant has not had his or her hospital medical staff privileges revoked, suspended, curtailed, limited, or surrendered while under investigation.

- 6. (f) The applicant acknowledges, on a form prescribed by the board, that he or she is subject to the continuing medical education requirements for physicians as specified in Chapter 14 of the rules and regulations of the State Board of Medical Examiners.
- 7.(g) The applicant furnishes a certification of the employment arrangements or agreement with the qualified clinic or nonprofit organization.
- (b) (h) A certificate of qualification issued under subsection (a) this rule shall be issued at no cost to the applicant.

## **USMLE Volunteer Spotlight**



Lois Krahn, M.D. Arizona Medical Board & USMLE Composite Committee

#### Brief Bio

I am delighted to serve on the USMLE Composite Committee that builds on my previous experience of being a member of the USMLE Management Committee. I am originally from Winnipeg in Manitoba, Canada and came to the US to attend college at Bryn Mawr College, followed by medical school at the Mayo Clinic Alix School of Medicine and graduate education at Georgetown University School of Medicine and the Mayo Clinic Graduate School of Medicine. My clinical interests have been most recently focused on sleep medicine, particularly for people with narcolepsy, idiopathic hypersomnia and similar conditions. My background is that I have served on the Arizona Medical Board for 11 years, a role that opened doors for me with the USMLE. My roles at Mayo Clinic have included teaching undergraduate and graduate medical education, giving me additional insight into the importance of the USMLE for newly graduated medical students and international medical graduates seeking licensure to independently practice medicine. In July 2025 after 31 years on staff I will retire from my role as Professor of Psychiatry to transition to emeritus status at the Mayo Clinic.

#### Reflection

My involvement with the USMLE has been particularly influential in my work as a member of the Arizona Medical Board as we seek to ensure that physicians have the needed knowledge and skills to serve the community. Like many US states, Arizona attracts physicians who have completed their medical studies at many different schools from the US and around the world. The USMLE program provides an invaluable common pathway to demonstrate the expected expertise required for the practice of medicine. Arizonans benefit from a group of doctors who hail from across the country and the world, but they first must have confidence that each licensed physician has the needed qualifications. The USMLE satisfies this critical part of the application for a medical license.

#### Value of the USMLE as a Member of a State Board

As a result of the many discussions and deliberations on USMLE committees, I have developed much more insight into the core requirements of a medical licensure application. I had familiarity with the USMLE program, but with active participation with several different committees of the USMLE I gained a deeper understanding into the overarching goals of the USMLE program and how it adapts over time. I have enjoyed developing relationships with the truly impressive staff of the USMLE who are deeply committed to use their impressive collective expertise to make the USMLE the premier medical licensure program in the world.

The USMLE program is grateful to Dr. Krahn for her service to the USMLE on behalf of the medical licensing board community. She is currently a member of the USMLE Composite Committee and has previously served on a USMLE Step 1 Standard Setting Panel; USMLE Step 3 Form Review; and the USMLE Management Committee.

### USMLE Orientation for State Board Members and Staff

FSMB will host the 19th annual USMLE Orientation for State Board Members and Staff on October 2, 2025, at FSMB's offices in Euless, Texas.

The orientation, first held in 2007, provides members and staff from state medical and osteopathic boards with an opportunity to learn about the USMLE program and engage directly with program staff. The goals of the workshop remain: (1) to inform and educate the medical board/regulatory community on the USMLE program, including new developments and key issues; (2) to create and facilitate relationships with USMLE program staff to ensure that state boards have an immediate resource for any USMLE-related questions; and (3) to share opportunities for state board members and staff to participate directly with the USMLE program. To date, 229 individuals from 61 boards have participated in an orientation. Sixty-six participants (representing 35 boards) have served subsequently with the USMLE program on standard setting panels and advisory panels, the USMLE Management Committee, the USMLE Composite Committee, and/or item writing and item review committees.

Board members and staff interested in participating in this year's Orientation should contact Frances Cain, Director of Assessment Services at FSMB.

## **USMLE and NBME Parts Transcripts**

FSMB now processes official transcripts for all NBME Parts examinees. This includes both physicians with only NBME Parts exam history and physicians with a combination of NBME Parts and USMLE history. The NBME Parts transcripts will be posted to the FSMB board portal, as is standard protocol for USMLE transcripts.

As previously communicated, as of August 2024 FSMB processes all official USMLE transcripts for all examinees. FSMB also processes transcripts for the FLEX and SPEX examinations.

We ask the state medical boards to reference <u>FSMB's website</u> as the source for obtaining USMLE, NBME Parts, FLEX and SPEX transcripts as part of their licensing application materials.

## Change to Step 2 CK Passing Standard Begins July 1, 2025

At its June 2025 meeting, the <u>USMLE Management Committee</u> conducted a review of the USMLE Step 2 CK passing standard. Management Committee members include individuals with experience on **state medical boards**, medical school and residency program faculty from across the U.S., practicing physicians, residents, and public members. The Committee decided that a four-point increase in the passing standard — used to determine a Pass or Fail outcome — will apply to Step 2 CK examinees testing on or after July 1, 2025. On the three-digit score scale, the passing standard will change from 214 to 218.

As part of the USMLE program's operational procedures and in alignment with best practices for licensing and certification exams, a scheduled comprehensive review and analysis of the passing standard for each Step exam typically occurs every three to four years. This ensures that the passing standard reflects current expectations concerning knowledge and skills needed to support effective medical practice and patient care.

The Management Committee determined this adjustment to the passing standard through the careful and thorough consideration of information from multiple sources, including:

- Recommendations from independent groups of physicians and educators unaffiliated with the USMLE who participated in content-based standard-setting panels in March and April 2025;
- Results of surveys of various groups (e.g., residency program directors, medical school faculty, state licensing representatives, examinees) concerning the appropriateness of the current passing standard for the Step 2 CK examination;
- Data on trends in examinee performance; and
- Score precision and its effect on the pass/fail outcome.

FSMB, on behalf of the USMLE program, would like to express our gratitude to the state medical board staff and members who participated in the Step 2 CK standard setting surveys and/or panels.

#### **USMLE Examinee Newsletter**

The USMLE program recently launched an electronic newsletter aimed at providing USMLE applicants and examinees with helpful information and key resources to help them along their journey to becoming a licensed physician. Updates about tools and services designed to help them track their progress and make the most of their study time are also provided.

## **CONSENT DECREE**

This matter comes before the Medical Licensure Commission of Alabama ("the Commission") on the Administrative Complaint ("the Administrative Complaint") filed by the Alabama State Board of Medical Examiners ("the Board") on July 17, 2025. The Board and the Respondent, Julian Orlando Simon Carlo, M.D. ("Respondent"), have entered into a Joint Settlement Agreement ("the Settlement Agreement"), and have asked the Commission to approve the Settlement Agreement and to embody it in this Consent Decree.

## **General Provisions**

1. <u>Approval of the Settlement Agreement</u>. After review, the Commission finds that the Settlement Agreement represents a reasonable and appropriate disposition of the matters asserted in the Administrative Complaint. The Commission therefore approves the Settlement Agreement.

- 4. <u>Additional Violations</u>. Any violation of the requirements of this Consent Decree, or any new violation of state or federal laws or regulations, may result in the Board filing a petition to discipline Respondent's medical license.

  Nothing in this Consent Decree precludes the Board from bringing new

administrative charges against Respondent based upon events and circumstances not raised in the Administrative Complaint.

- 5. <u>Retention of Jurisdiction</u>. The Commission retains jurisdiction for the purpose of entering such other and further orders and directives as may be required to implement the provisions of this Consent Decree.
- 6. Official Notice. Pursuant to Ala. Code § 41-22-13(4), Respondent is informed that the Board and/or the Commission may at any time take official notice of this Consent Decree, and/or any of the Findings of Fact herein, and may deem any of the findings or conclusions set forth in this Consent Decree to be conclusively established, all without further notice to Respondent.

Pursuant to Title 41 section 41-22-11 the Respondent seeks a declaratory ruling by the Alabama State Board of Medical Examiners with respect to the applicability of any rule or statute that supports the enforceable authority of the Board or Commission to require the Respondent to submit to and undergo neurological testing in the absence of a declared emergency.
- 2. Pursuant to Title 41 section 41-22-11 the Respondent seeks a declaratory ruling by the Medical Licensure Commission of Alabama of how it can entertain a charge for violation of a Board's order that is void for lack of adoption of a Rule pursuant to the Alabama Administrative Procedures Act. (AAPA)

Respondent's requests for the issuance of a declaratory judgment are due to be denied. The Commission's administrative rule governing the submission and consideration of requests for declaratory rulings provides:

- (1) Any persons substantially affected by a rule may petition the Commission for a declaratory ruling with respect to the validity of a rule or the applicability to any person, property or state of facts of any rule or statute enforceable by it or with respect to the meaning and scope of any order of the Commission.
  - (2) The petition shall be in writing and shall include:
    - (a) the name and address of the petitioner;

- (b) a statement of facts sufficient to show that the person seeking relief is substantially affected by the rule;
- (c) the rule, statute or order and the reasons for the questions.
- (3) The petition will be considered and answered in writing by the Commission within forty-five days unless the Commission is unable to reach a decision on the facts presented.
- (4) Circumstances in which rulings shall not be issued include but are not necessarily limited to:
  - (a) lack of jurisdiction;
  - (b) lack of clarity of the issues presented;
  - (c) no clear answer determinable.
- (5) In the event the Commission declines to issue a ruling, the petitioner shall be notified in writing that the request for a declaratory ruling was denied and the reasons therefor shall be specified.

Ala. Admin. Code r. 545-X-1-.09.

Respondent's requests for declaratory rulings do not comply with the foregoing Rule. The request does not contain the plain and simple information required in Rule 545-X-1-.09(2) (a)-(c). Respondent's first request, while directed to the Commission, actually requests a declaratory ruling from the Board. The Commission lacks authority to make a declaratory ruling as to the applicability, effect, or interpretation of any Board rule. Respondent's second request is a hypothetical and rhetorical question, and does not seek the Commission's

declaratory determination as to how a specific Commission rule would apply to Respondent under a certain specific state of facts.

- 9. Motion to Dismiss Counts One and Two, Suppress Evidence, and Enforce Federal Confidentiality, filed May 19, 2025;
- 10. Motion to Document and Refer Confidentiality Violations by the APHP Under 42 CFR Part 2, filed May 20, 2025;
- 11. Motion to Strike and Seal Administrative Complaint from Public Record For Violation of Federal Confidentiality Law, filed May 19, 2025;
- 12. Omnibus Motion to Quash Subpoenas And Exclude All Part 2
  Protected Records, Directly Derived Testimony, and Unlawfully
  Tainted Derivative Evidence from
  , and All Law Enforcement Personnel Involved in
  the July 26, 2024 Incident, filed May 27, 2025;
- 13. Supplemental Memorandum In Support of Omnibus Motion to Quash Subpoenas and Exclude Part 2 Protected Records, Testimony, and Derivatively Tainted Evidence, filed May 27, 2025;
- 14. Motion for Clarification and Reconsideration of May 26, 2025 Order Granting Subpoenas, Rendered Prior to Receipt and Consideration of Respondent's Timely Filed Substantive Objections, filed May 28, 2025; and
- 15. Notice of Filing Supplemental Evidence, filed June 25, 2025.

The Commission has received and reviewed all of the foregoing pleadings, and has made all of them part of the administrative record in this matter. The Commission acknowledges that Respondent has the right to represent himself in this matter and has chosen to do so.

With respect to the above-numbered item #11, the Commission notes that all administrative complaints filed with the Commission are, by statute, public records. *See* Ala. Code § 34-24-361.1. In view of Respondent's invocation of his rights under 42 C.F.R. Part 2, however, the Commission has reviewed the publicly-available version of the Administrative Complaint and has applied additional redactions to protect against disclosure of information that may potentially be protected by the Part 2 rules. The further-redacted Administrative Complaint remains publicly available information in accordance with applicable statutes.

On June 6, 2025, we entered an order summarily suspending Respondent's license to practice medicine in Alabama pursuant to the provisions of Ala. Code § 34-24-360(19)b.-f., and continuing the hearing in this matter indefinitely. Respondent is pursuing judicial review of that order. Accordingly, all matters pertaining to the ultimate hearing in this matter are moot at this time.

Upon consideration by the full Commission, it is ordered that Respondent's motions referenced above are denied as most except as expressly provided otherwise above. Of course, our denial of the relief requested by the Respondent is without prejudice to Respondent's requesting the same relief and asserting the

same rights, if and when this matter proceeds to a contested case hearing before the Commission.

## FINDINGS OF FACT AND CONCLUSIONS OF LAW

This matter came before the Medical Licensure Commission of Alabama for a contested case hearing on July 23, 2025. After receiving and considering all of the relevant evidence and argument, we find the Respondent, André Vontral Haynes, M.D., guilty of two of the three disciplinary charges presented by the Board and impose professional discipline as set forth below.

# I. Introduction and Procedural History

The Respondent in this case is André Vontral Haynes, M.D. ("Respondent"). Respondent is a licensee of this Commission who, at the relevant times, practiced addiction medicine via telemedicine from his home in Georgia. Respondent was first licensed by the Commission on September 12, 2008, having been issued license no. MD.29119.

This is Respondent's second contested case proceeding before the Commission in recent years. In 2023, we heard a contested-reinstatement proceeding involving Respondent that culminated in Findings of Fact and Conclusions of Law entered on July 14, 2023. In those findings, we found Respondent guilty of three disciplinary violations, and simultaneously reinstated his license to practice medicine in Alabama, reprimanded his license, imposed administrative fines, and required Respondent to complete four specific continuing medical education courses relating to addiction medicine and telemedicine.

Respondent's first contested case before us centered on his continued practice of medicine in Alabama during a period of time in which his license to practice medicine was expired and inactive. This case involves Respondent's continuing to prescribe controlled substances in Alabama during later time periods in which he held a *license to practice medicine* in Alabama, but did not possess an Alabama Controlled Substances Certificate ("ACSC").

This contested case began with an Administrative Complaint filed by the Board with the Commission on or about January 23, 2025. The Administrative Complaint contains three counts. In Count One, the Board alleges that Respondent is guilty of "[f]ailure to comply with any rule of the Board of Medical Examiners" in violation of Ala. Code § 34-24-360(23), in that he violated Ala. Admin. Code r. 540-X-4-.01(1) by "knowingly and intentionally [writing] prescriptions for

controlled substances to patients in Alabama without possessing an Alabama Controlled Substances Certificate." Count Two, based on the same basic facts as Count One, alleges that Respondent's prescribing of controlled substances in Alabama without a valid ACSC violated the Commission's rules against "unprofessional conduct," in violation of Ala. Code § 34-24-360(2) and Ala. Admin. Code r. 545-X-4-.06. Finally, in Count Three, the Board alleges that Respondent failed to utilize medically appropriate risk and abuse mitigation strategies in connection with his prescribing of controlled substances in Alabama, in that he failed to query patients in the Alabama Prescription Drug Monitoring Program ("PDMP") prior to writing prescriptions, in violation of Ala. Admin. Code r. 540-X-4-.09 and Ala. Code § 34-24-360(23). On grounds of these three Counts, the Board moves the Commission "to revoke the license to practice medicine of Respondent, assess the maximum fine, and/or take such other actions as the Commission may deem appropriate based upon the evidence presented for consideration."

On July 23, 2025, we conducted a full evidentiary hearing as prescribed in Ala. Admin. Code r. 545-X-3. The case supporting disciplinary action was presented by the Alabama Board of Medical Examiners through its attorneys E. Wilson Hunter and Alicia Harrison. Respondent appeared before the Commission and testified in person without legal counsel. Pursuant to Ala. Admin. Code r. 545-X-3-.08(1), the Honorable William R. Gordon presided as Hearing Officer. Each side was offered

the opportunity to present evidence and argument in support of its respective contentions, and to cross-examine the witnesses presented by the other side. Board Exhibits 1-29 were received into evidence without objection. After careful review, we have made our own independent judgments regarding the weight and credibility to be afforded to the evidence, and the fair and reasonable inferences to be drawn from it. Having done so, and as prescribed in Ala. Code § 41-22-16, we enter the following Findings of Fact and Conclusions of Law.

## II. Findings of Fact

- 1. Respondent was first licensed to practice medicine in Alabama on September 12, 2008, under license number MD.29119. With the exception of an inactive period between January 2022 and July 2023, he has maintained licensure at all material times.
- 2. The following factual findings from our July 14, 2023 Findings of Fact and Conclusions of Law (hereinafter "July 2023 Findings") are officially noticed and are deemed to be conclusively established for purposes of this proceeding:
  - 1. Respondent was first licensed by the Commission on or about September 12, 2008, having been issued license no. MD.29119.
  - 2. Respondent lives in a suburb of Atlanta, Georgia. To the extent relevant to these proceedings, Respondent's medical practice primarily consists of providing telemedicine-based addiction medicine services to patients suffering from opioid dependency.
  - 3. Respondent failed to renew his license to practice medicine in Alabama at the end of 2021. As a result, Respondent's

medical license and his Alabama Controlled Substances Certificate ("ACSC") became inactive by operation of law on December 31, 2021.

- 4. Respondent continued to provide treatment to patients located in Alabama during 2022, even though he did not have an active license to do so. Respondent also continued to write prescriptions for patients in Alabama during 2022, including prescriptions for controlled substances, although he did not have an active ACSC. Specifically, during 2022, Respondent's Prescription Drug Monitoring Program ("PDMP") Prescriber Activity Report shows—and Respondent admits—that he wrote over 200 prescriptions for controlled substances to approximately 20 different patients in Alabama during 2022.
- 5. On February 7, 2023, a representative of the Board contacted Respondent by phone and informed him that he did not have a license to practice medicine in Alabama, and that he should adapt his behavior accordingly.
- 3. In our July 2023 Findings, we adjudged Respondent guilty of, among other things, unprofessional conduct "in that, from approximately January 1, 2022 through at least February 7, 2023, he practiced medicine and prescribed controlled substances in the State of Alabama at least 200 times without a valid license to do so."
- 4. The present disciplinary case essentially picks up where the 2023 proceedings left off. Although we reinstated Respondent's license to practice medicine in July 2023, Respondent failed to apply to the Board for reinstatement of his ACSC until December of that year.
- 5. In December 2023, when Respondent was in the process of renewing his annual license registration for the upcoming 2024 calendar year, he realized that

he did not have an active ACSC. On December 12, 2023, a Credentialing Specialist for the Board e-mailed the ACSC Reinstatement Application to Respondent. The Credentialing Specialist also generated an activity report from the Alabama PDMP, which showed that 301 prescriptions for controlled substances written by Respondent had been filled in Alabama pharmacies between January 1, 2022 and December 21, 2023. The Credentialing Specialist requested that Respondent provide a narrative explanation for this, inasmuch as Respondent had not held a valid ACSC since December 31, 2021. (Board Ex. 19.)

## 6. Respondent replied to the Credentialing Specialist's inquiry as follows:

Yes Ma'am. I had been writing prescriptions and there was a misunderstanding of what I interpreted the rules to be during Covid. The Alabama Medical Board meet [sic] with me and discussed my actions. In the end, I plead [sic] guilty to the charges and they reinstated my license after I paid a fine and completed some CME regarding addiction treatment. I was unaware that when my license was reinstated by the Medical Board this year that my ASCS [sic] was not renewed with it. I didn't realize this until today when I was renewing for the year my Alabama Medical License.

(Board Ex. 19.)

<sup>&</sup>lt;sup>1</sup> The date range of January 1, 2022 through December 21, 2023 includes some period of time that we have already addressed in our July 2023 Findings. In this case, we are concerned only with periods of time in which Respondent had a valid license to practice medicine in Alabama, but lacked a valid ACSC authorizing him to prescribe controlled substances in Alabama. Accordingly, today's actions are based only on Respondent's continuing to prescribe controlled substances after July 14, 2023, and especially on his continued prescribing of controlled substances in Alabama after he was warned by the Board and openly acknowledged that he did not have a valid ACSC.

- 7. The Credentialing Specialist, on December 27, 2023, replied with a clear warning that Respondent could not write prescriptions for controlled substances in Alabama unless and until his ACSC was reinstated. She explained: "Please note that this means that you cannot write controlled substances prescriptions until the application is approved. Do not hesitate to reach out if you have any questions." (Board Ex. 20.) A few hours later, Respondent replied, "Understood. Thank you and I hope you have a wonderful New Year." (Id.)
- 8. In March 2024, the same Credentialing Specialist noticed that Respondent had not paid the reinstatement application fee for his ACSC. Because of that, his ACSC reinstatement application had not been presented to the Board for consideration. On March 5, 2024, therefore, the Credentialing Specialist e-mailed Respondent to remind him to complete the payment process. After Respondent did so, the Credentialing Specialist again reminded Respondent that he was prohibited from writing prescriptions for controlled substances in Alabama until the Board actually approved reinstatement of his ACSC. She wrote: "Please be aware that your ACSC is not active. Therefore, you should not be writing controlled substances prescriptions under any circumstances." (Board Ex. 21.) Again, a few hours later, Respondent replied, "Ok understood. Thank you." (Id.)
- 9. On April 17, 2024, an Assistant General Counsel for the Board sent Respondent a formal written demand that he cease and desist from prescribing

controlled substances to patients in Alabama. The Assistant General Counsel's cease-and-desist demand letter read as follows:

### Dear Dr. Haynes:

The Alabama State Board of Medical Examiners ("the Board") is the licensing and regulatory agency charged with protecting the health and safety of Alabama patients. In furtherance of this duty, the Board is charged with ensuring that only those persons who possess a valid Alabama Controlled Substances Certificate ("ACSC") prescribe controlled substances to Alabama patients. The Board recently learned that you prescribed controlled substances to Alabama patients in 2022, 2023 and 2024, though you allowed your ACSC to lapse on December 31, 2021.

Last year, the Board conducted an investigation into your continued practice of medicine in Alabama following the expiration of your medical license and ACSC on December 31, 2021. The investigation was initiated when you submitted a request for reinstatement of your medical license on January 23, 2023. During the process of reviewing your application for reinstatement, the Board learned that you were practicing telemedicine without an active license to practice medicine in Alabama, and that you wrote approximately 204 prescriptions for patients in Alabama between February 2022 and February 2023, including prescriptions for controlled substances such as Buprenorphine and Suboxone. On March 22, 2023, the Board sent you a letter asking you to cease and desist from the unauthorized practice of medicine in Alabama.

On June 28, 2023, you participated in a full evidentiary hearing on these charges before the Medical Licensure Commission of Alabama (the "Commission"). On or about July 14, 2023, the Commission issued Findings of Fact and Conclusions of Law and determined that you violated Ala. Code § 34-24-360(2) in that, from approximately January 1, 2022 through at least February 7, 2023, you practiced medicine and prescribed controlled substances in the State of Alabama at least 200 times without a valid license to do so. The Commission reinstated your medical license to full and unrestricted status, reprimanded your license, assessed an administrative fine and

ordered you to attend continuing medical education courses in addiction medicine.

Despite your recent interaction with the Board and Commission, you continue to violate Alabama law by prescribing controlled substances to patients in Alabama without a valid ACSC. A report from the Prescription Drug Monitoring Program ("PDMP") reveals that between March 22, 2023 and March 5, 2024, you wrote eighty (80) prescriptions for controlled substances to thirteen (13) Alabama patients, despite the fact that you allowed your ACSC to lapse on December 31, 2021.

On December 27, 2023 and again on March 5, 2024, the Board advised you to refrain from writing prescriptions for controlled substances. You acknowledged this directive in an email, yet disregarded the warning and wrote thirteen (13) prescriptions for six (6) patients, out of the eighty (80) mentioned above.

Pursuant to Ala. Admin. Code r. 540-X-4-.01, "[e] very physician licensed to practice in Alabama who distributes, prescribes, or dispenses any controlled substance within Alabama or who proposes to engage in the distributing, prescribing or dispensing of any controlled substance within Alabama must obtain annually a registration certificate [i.e., an ACSC]." Renewal must occur on or before December 31 of each year. See Ala. Admin. Code r. 540-X-4-.03. Due to your failure to renew your ACSC, it is the order of the Board that you immediately cease and desist from prescribing controlled substances to any patient in Alabama. If you do not immediately comply with this demand, the Board will engage all lawful means necessary to compel your compliance with Alabama law.

The Board is aware that you submitted an Alabama Controlled Substances Registration Certificate Renewal on or about December 21, 2023. The Board has decided, however, to defer your ACSC application pending further investigation into your prescribing of controlled substances. Therefore, the pending request for reinstatement in no way authorizes you to prescribe to patients in Alabama.

If you feel the Board's investigation is in error, you may reply to this letter in writing and present any information you deem pertinent. In the meantime, you must comply with the Board's order to cease and desist the unlawful practice of medicine. If you have legal counsel, please provide him or her with a copy of this letter.

Should you have any further questions regarding this matter, please feel free to contact me.

(Board Ex. 22 (emphasis in original).)

10. On May 7, 2024, a Board Investigator traveled to Respondent's residence in Stockbridge, Georgia, and met with Respondent in person. At this meeting, the Board Investigator notified Respondent that he was under a formal investigation by the Board. (Board Ex. 23, 24.) The Board Investigator contemporaneously made the following "Report of Interview":

On May 7, 2024, I travelled to Stockbridge, Ga where I met with [Respondent] at his residence. [Respondent] provides addiction medicine via telemedicine from his home. During our conversation, [Respondent] told me that when he renewed his Alabama medical license, he thought he was renewing his license and his Alabama Controlled Substance Certificate (ACSC) at the same time; however, later he learned he had not renewed his ACSC. [Respondent] stated he "scrubbed" his patient list and thought he removed all Alabama patients but one or two got through. I told [Respondent] that he cannot prescribe controlled substances to Alabama patients until his ACSC is reinstated.

(Board Ex. 24.)

11. Respondent provided the following written response to the Board's notice of investigation, in which he again pleaded that he did not realize that he had to reinstate his ACSC separately from his medical license:

Dear Members of the Alabama Board of Medical Examiners,

I am writing to address the investigation concerning the expiration of my Controlled Substance license and the subsequent

writing of controlled substances during the period when my Alabama Medical License had lapsed. This occurred during the COVID-19 timeframe, and I was found to be in violation.

Upon discovery of this oversight, I took immediate corrective actions, including paying the required fine and completing additional Continuing Medical Education (CME) courses. Consequently, the Alabama Medical Board reinstated my medical license.

I was under the impression that both my medical license and my Controlled Substance certificate were renewed simultaneously during this process. Unlike previous renewals, this renewal did not occur as expected, and I was unaware that I needed to renew them separately upon reinstatement of my license. Once I realized this error, I promptly applied for the Controlled Substance certificate. It was at this point that I was informed of the need for an investigation.

Enclosed are the records of patients seen in my addiction clinic, as requested. I am committed to full transparency and cooperation throughout this investigation. Should you require any further information or have additional questions, please do not hesitate to contact me.

Thank you for your attention to this matter.

(Board Ex. 25.)

12. Thus, between December 2023 and May 2024, Respondent received at least four specific warnings from the Board that he did not have a valid ACSC and could not write prescriptions for controlled substances in Alabama: two warnings from the Board's Credentialing Specialist in December 2023 and March 2024, a formal written demand to cease and desist from the Board's Assistant General Counsel in April 2024, and a personal visit from a Board Investigator in May 2024.<sup>2</sup>

<sup>&</sup>lt;sup>2</sup> These four warnings, of course, came after and in addition to our July 2023 Findings.

Respondent consistently expressed understanding of these warnings, and consistently explained to the Board that he had mistakenly believed that his ACSC had been reinstated together with his medical license.

-

- 13. Even after these warnings, Respondent continued to write prescriptions for controlled substances in Alabama. Alabama PDMP records disclose that after the Credentialing Specialist's first warning of December 27, 2023, Respondent wrote at least 37 separate prescriptions for controlled substances to seven different patients with home addresses in Alabama, all of which were filled in Alabama pharmacies. Even worse, Respondent wrote 10 of those 37 illegal prescriptions after he received a cease-and-desist demand from a Board attorney and an in-person visit from a Board Investigator. (Board Ex. 27.)
- 14. In his testimony before the Commission, Respondent admitted that he did not check the Alabama PDMP database before prescribing controlled substances to Alabama residents. Respondent testified, however, that he did check the analogous Georgia system every time he prescribed controlled substances, and that he was able to see Alabama PDMP data through the Georgia system via a datasharing agreement between Alabama and Georgia. This testimony is plausible and is uncontroverted by the Board. We therefore credit Respondent's testimony that he did regularly review the Georgia PDMP system. Having done so, we further conclude as a factual matter that the Georgia PDMP system placed Respondent on

notice that the prescriptions he was writing to patients with Alabama home addresses were in fact being filled in Alabama pharmacies.

- 15. Respondent further claimed in his testimony before the Commission that, at the beginning of telemedicine encounters with Alabama patients, he would ask the patients where they were located, and ensure that they reported that they were located in Georgia before proceeding with the appointment. Sometimes, Respondent claimed, patients would drive in their vehicles from their homes in Alabama into Georgia so that they could have telemedicine encounters with Respondent. Respondent claims that he would inform those patients that if they were physically located in Alabama, he could not prescribe controlled substances to them, but if they were located in Georgia, he could. Respondent admits, however, that he did not document these conversations in his medical records.
- 16. We discredit this portion of Respondent's testimony because it is inconsistent with the balance of the evidence, including (a) Respondent's previous claim that he had "scrubbed" his patient list of Alabama patients, (b) Respondent's previous repeated claims that he simply did not realize that his ACSC was not reinstated along with his Alabama medical license, and (c) the lack of documentation of such conversations in his medical records. Even if we were to credit Respondent's testimony in this regard, however, we would have serious reservations about whether the procedure described by Respondent would discharge his professional obligation

to ensure that he was not prescribing controlled substances in states where he was not legally authorized to do so.

### III. Conclusions of Law

- 1. The Medical Licensure Commission of Alabama has jurisdiction over the subject matter of this cause pursuant to Act No. 1981-218, Ala. Code §§ 34-24-310, et seq. Under certain conditions, the Commission "shall have the power and duty to suspend, revoke, or restrict any license to practice medicine or osteopathy in the State of Alabama or place on probation or fine any licensee." Ala. Code § 34-24-360. In addition to all other authorized penalties and remedies, the Commission may impose a fine of up to \$10,000.00 per violation and may require the payment of administrative expenses incurred in connection with the disciplinary proceeding. Ala. Code § 34-24-381(a), (b).
- 2. Respondent was properly notified of the time, date and place of the administrative hearing and of the charges against him in compliance with Ala. Code §§ 34-24-361(e) and 41-22-12(b)(1), and Ala. Admin. Code r. 545-X-3-.03(3), (4). At all relevant times, Respondent was a licensee of this Commission and was and is subject to the Commission's jurisdiction.
- 3. Before making any decision on a contested case such as this one, the Commission is required by law to "receive and consider" a recommendation from the Board. The Board's recommendation, however, is not binding upon the

Commission. See Ala. Code § 34-24-311. The Commission has received and duly considered the Board's non-binding recommendation to find Respondent guilty of the disciplinary allegations outlined in the Administrative Complaint, revoke his license to practice medicine, and impose the maximum fine.

In Count One of the Administrative Complaint, the Board alleges that Respondent should be disciplined for violating an applicable Rule of the Board. The Commission is authorized, after notice and hearing, to impose professional discipline on any physician who is shown to have "[f]ail[ed] to comply with any rule of the Board of Medical Examiners . . . . " Ala. Code § 34-24-360(23). An applicable Board Rule, in turn, provides that "[e] very physician licensed to practice in Alabama who distributes, prescribes, or dispenses any controlled substance within Alabama. . . must obtain annually a registration certificate." Ala. Admin. Code r. 540-X-4-.01(1). The evidence before the Commission clearly substantiates that, between July 15, 2023 and the date of the hearing in this matter, Respondent prescribed controlled substances to patients located in Alabama. It is undisputed that Respondent did not, at any time after December 31, 2021, hold the "registration certificate" (i.e., an ACSC) required by Ala. Admin. Code r. 540-X-4-.01(1). The evidence further substantiates that Respondent continued to prescribe controlled substances to patients located in Alabama after receiving multiple pointed warnings from the Board, rendering his violations knowing and voluntary.

- 5. Count Two accuses Respondent of "unprofessional conduct." The Commission may discipline any physician who, after notice and hearing, is shown to have engaged in "[u]nprofessional conduct as defined herein or in the rules and regulations promulgated by the commission." Ala. Code § 34-24-360(2). As relevant to the charges at issue in this case, our Rules define "unprofessional conduct" to include the "commission or omission of any act that is detrimental or harmful to the patient of the physician or detrimental or harmful to the health, safety, and welfare of the public, and which violates the high standards of honesty, diligence, prudence and ethical integrity demanded from physicians and osteopaths licensed to practice in the State of Alabama." Ala. Admin. Code r. 545-X-4-.06. For substantially the same reasons as outlined above, the evidence of record substantiates that Respondent is guilty of unprofessional conduct.
- 6. Count Three faults Respondent for not checking the PDMP database before prescribing controlled substances to patients in Alabama. Board Rule 540-X-4-.09 provides, in relevant part:
  - (3) Every practitioner shall utilize medically appropriate risk and abuse mitigation strategies when prescribing controlled substances. Examples of risk and abuse mitigation strategies include, but are not limited to:
    - (a) Pill counts;
    - (b) Urine drug screening;
    - (c) PDMP checks;

- (d) Consideration of abuse-deterrent medications;
- (e) Monitoring the patient for aberrant behavior;
- (f) Using validated risk-assessment tools, examples of which shall be maintained by the Board; and
- (g) Co-prescribing naloxone to patients receiving opioid prescriptions when determined to be appropriate in the clinical judgment of the treating practitioner.

Ala. Admin. Code r. 540-X-4-.09(3) (emphasis added).

- 7. Because we have credited Respondent's testimony that he did in fact check patients' Alabama PDMP data through the Georgia PDMP system before prescribing controlled substances, the evidence does not substantiate the alleged violation of Ala. Admin. Code r. 540-X-4-.09.
- 8. We have carefully weighed whether any sanction less than license revocation could be an adequate response to the factual and legal findings outlined above, particularly when viewed in context of the July 2023 Findings. Ultimately, however, we have concluded that only the sanction of revocation of Respondent's license to practice medicine in Alabama is a sufficient response to Respondent's repeated violations of Alabama law. When we considered reinstatement of Respondent's medical license in 2023—which was opposed by the Board—we extended leniency to Respondent in light of the extensive violations that were proved up by the Board. We reasonably expected that a contested case hearing, a public reprimand, \$15,000.00 in administrative fines, and required continuing education

would be sufficient to impress upon Respondent the seriousness of his violations, and would serve as a well-calibrated "wake-up call" sufficient to deter future violations. That expectation has proven to be unfounded. Respondent has continued to violate Alabama law even after multiple repeated warnings. Respondent's consistent pattern of disregard of Alabama law is simply irreconcilable with continued licensure as a medical doctor in our State.

9. We reach all of these decisions based on all of the facts presented, viewed through the lens of our professional experience, expertise, and judgment. See Ala. Code § 41-22-13(5) ("The experience, technical competence, and specialized knowledge of the agency may be utilized in the evaluation of the evidence.").

### IV. Decision

Based on all of the foregoing, it is ORDERED, ADJUDGED, AND DECREED:

- 1. That the Respondent, André Vontral Haynes, M.D., is adjudged GUILTY of failure to comply with a Board Rule in violation of Ala. Code § 34-24-360(23) and Ala. Admin. Code r. 540-X-4-.01(1) as charged in Count One of the Administrative Complaint;
- 2. That the Respondent, André Vontral Haynes, M.D., is adjudged GUILTY of unprofessional conduct in violation of Ala. Code § 34-24-360(2) and

Ala. Admin. Code r. 545-X-4-.06 as charged in Count Two of the Administrative Complaint;

- 3. That the Respondent, André Vontral Haynes, M.D., is adjudged NOT GUILTY of the alleged violations of Ala. Code § 34-24-360(23) and Ala. Admin. Code r. 540-X-4-.09 as charged in Count Three of the Administrative Complaint;
- 4. That, separately and severally for Counts One and Two of the Administrative Complaint, Respondent's license to practice medicine in the State of Alabama is REVOKED:
- 5. That Respondent shall, within 30 days of this Order,<sup>3</sup> pay an administrative fine in the amount of \$10,000.00 as to Count One of the Administrative Complaint, and \$10,000.00 as to Count Two of the Administrative Complaint, for a total administrative fine of \$20,000.00; and
- 6. That within 30 days of this order, the Board shall file its bill of costs as prescribed in Ala. Admin. Code r. 545-X-3-.08(10)(b), and Respondent shall file any objections to the cost bill within 10 days thereafter, as prescribed in Ala. Admin. Code r. 545-X-3-.08(10)(c). The Commission reserves the issue of imposition of costs until after full consideration of the Board's cost bill and Respondent's

objections, and this reservation does not affect the finality of this order. See Ala. Admin. Code r. 545-X-3-.08(10)(e).

### FINDINGS OF FACT AND CONCLUSIONS OF LAW

This contested license reinstatement proceeding came before the Medical Licensure Commission of Alabama for a contested case hearing on July 23, 2025. After receiving and considering all of the relevant evidence and argument, we find the Respondent, Kamaledin Hassan Kamal, M.D., guilty of the disciplinary charge presented by the Board and deny Dr. Kamal's application for license reinstatement.

# I. Introduction and Procedural History

The Respondent in this case is Kamaledin Hassan Kamal, M.D. ("Respondent"). Respondent is a former licensee of this Commission who was first licensed on January 1, 2007, having been issued license no. MD.27906.

Respondent failed to renew his license to practice medicine at the end of 2009, which resulted in his license expiring by operation of law on December 31, 2009.

On August 2, 2024, Respondent filed an Application for Reinstatement pursuant to Ala. Code § 34-24-337. On December 5, 2024, the Board, as prescribed in Ala. Code § 34-24-337(e), filed its "Notice of Intent to Contest Reinstatement." Then, on January 3, 2025, as prescribed in Ala. Code § 34-24-337(g), the Board filed its Administrative Complaint setting forth the particular factual and legal grounds for its opposition to reinstatement of Respondent's license (the "Administrative Complaint"). The Administrative Complaint contains just one count, alleging that Respondent is guilty of "Unprofessional Conduct" in violation of Ala. Code § 34-24-360(2) and Ala. Admin. Code r. 545-X-4-.06(19). More specifically, the Board alleges that Respondent "engaged in unprofessional conduct when he failed to furnish to the Board documentation relating to the medical malpractice lawsuit settled on his behalf in May of 2013, after being requested to do so on more than one occasion..."

On July 23, 2025, we conducted a full evidentiary hearing as prescribed in Ala. Admin. Code r. 545-X-3. The case supporting disciplinary action was presented by the Alabama Board of Medical Examiners through its attorneys E. Wilson Hunter and Alicia Harrison. Respondent did not appear, and the hearing was held *in absentia* as authorized in Ala. Code §§ 34-24-361(e)(10) and 41-22-12(d). Pursuant to Ala. Admin. Code r. 545-X-3-.08(1), the Honorable William R. Gordon presided as Hearing Officer. Each side was offered the opportunity to present evidence and

argument in support of its respective contentions, and to cross-examine the witnesses presented by the other side (though Respondent, as noted above, declined this opportunity). Board Exhibits 1-16 were received into evidence. After careful review, we have made our own independent judgments regarding the weight and credibility to be afforded to the evidence, and the fair and reasonable inferences to be drawn from it. Having done so, and as prescribed in Ala. Code § 41-22-16, we enter the following Findings of Fact and Conclusions of Law.

### II. Findings of Fact

- 1. Respondent was first licensed to practice medicine in Alabama on January 1, 2007, under license number MD.27906.
- 2. In 2007, Respondent was practicing as a hospitalist at Eliza Coffee Memorial Hospital in Florence, Alabama. On or about November 30, 2007, an incident apparently occurred in which patient "CRH" arrived at the hospital with severe hyponatremia (i.e., an abnormally low concentration of sodium in the blood). While we lack further factual details, it appears that CRH suffered neurological complications as a result of the measures taken to address her hyponatremia.
- 3. On November 19, 2009, CRH filed a medical-malpractice lawsuit against Respondent and nine other defendants in the Circuit Court of Lauderdale County, Alabama. (Board Ex. 8.) In the lawsuit, CRH alleged, among other things, that the defendants collectively (without attributing particular faults to particular

individual defendants) "improperly corrected [CRH's] sodium level, and they utilized 'hot salts' and/or hypertonic saline when not indicated and/or not needed and they failed to monitor and/or correct their utilization of 'hot salts' and/or hypertonic saline in their care and treatment of [CRH]." (Board Ex. 8 at 4.) CRH further alleged in her lawsuit that, as a result of the defendants' substandard care, she developed "extrapontine and/or central pontine myelinolysis and/or permanent brain damage." (Id.)

- 4. Respondent failed to renew his license to practice medicine at the end of 2009, which resulted in his license expiring by operation of law on December 31, 2009.
- 5. CRH's malpractice lawsuit was settled in May 2013. The total gross settlement amount was \$1,410,000.00, of which \$350,000.00 was paid on Respondent's behalf. (Board Ex. 2 at 13; Board Ex. 5; Board Ex. 9.) A report of the settlement was made to the Board on or about June 18, 2013. (Board Ex. 15.)
- 6. On April 23, 2014, Larry D. Dixon, then-Executive Director of the Board, wrote a letter to Respondent requesting documentation of the malpractice claim and settlement. (Board Ex. 16.) Mr. Dixon's correspondence read as follows:

### Dear Dr. Kamal:

The Board of Medical Examiners has received notice of your recent malpractice settlement and is interested in the circumstances which resulted in this action. The Board is requesting information by way of this letter under authority of Section 34-24-56, <u>Code of Alabama</u>, 1975,

which requires physicians to report malpractice actions resulting in either judgments or settlements, and Section 34-24-57, <u>Code</u>, which requires this Board to review cases involving alleged medical malpractice.

The attached sheet lists the specific types of information which are required. Any additional information which you may care to share with the Board will be appreciated. Please note that all records become the property of the Board and cannot be returned.

The Board will appreciate having the requested information by **Friday**, **June 20**, **2014**. It is your responsibility to insure that all of the records and requested information are gathered and submitted to the Board.

If you have any questions concerning this request please contact this office and ask to speak to Meredith Marshall, the staff member responsible for gathering these materials. Thank you for your attention to this matter and for your cooperation.

(Board Ex. 16 (boldface in original).)

- 7. Respondent did not submit any information in response to Mr. Dixon's letter.
- 8. In early 2015, with the Board's annual malpractice review process in view, the Board made an additional request to Respondent for information about CRH's claim. Respondent did not provide any information in response to this request, either.
- 9. By the time of the Board's 2015 annual malpractice review process, the Board had not received any substantive information about CRH's malpractice claim, and Respondent's Alabama medical license had been inactive for a few years. On the tracking sheet for CRH's claim against Respondent, therefore, the Board noted:

"No information was sent. ... Flag the applicant to receive more information before reinstatement of license is made." (Board Ex. 6.)

- 10. Respondent filed his application for reinstatement on or about August 2, 2024. (Board Ex. 2.) In his reinstatement application, Respondent disclosed the settlement of CRH's claim against him. In his narrative of the incident, Respondent wrote, "The patient admitted was admitted to the hospital with hyponatremia. The patient developed neurological complications due to fast correction of the hyponatremia." (Board Ex. 2 at 13; Board Ex. 5.)
- 11. Credentialing staff again requested that Respondent provide documents regarding CRH's malpractice claim and its settlement. On August 7, 2024, Tracy Hall, a "Credentialing Specialist" with medlicense.com, replied, "In reference to the malpractice documents, [Respondent] does not have any since it was so long ago (2007, settled in 2011) >\*\*<" (Board Ex. 12.)
- 12. On October 18, 2024, William Perkins, Executive Director of the Board, corresponded with Respondent inviting him to participate in an interview with the Board's Credentials Committee, and again requesting documentation regarding CRH's malpractice claim and settlement. (Board Ex. 13.) Mr. Perkins' correspondence read as follows:

### Dear Dr. Kamal:

I have been instructed by the Alabama State Board of Medical Examiners (the Board) to request your attendance at a meeting with the

Credentials Committee of the Board, Wednesday, November 13, 2024, at 1:30 p.m. CST. The meeting will be held in the Dixon-Parker Building, 848 Washington Avenue, Montgomery, Alabama, 36104.

The Board has received your application for medical license reinstatement, and the Committee would like to discuss this with you. Please make every effort to attend this meeting as the Board wishes to hear from you as they consider your application.

In addition, you should bring with you, or provide ahead of the interview, any documentation and/or records concerning the previous settlement made on your behalf concerning patient [CRH]. You have failed to provide this information on two occasions when previously requested by the Board. You may submit the documentation to Amy Dorminey, Operations Director, to the address above or via email to adorminey@albme.gov.

We look forward to meeting with you on the 13th of November. Upon receipt of this correspondence, please confirm with Mandy Ellis, Board Secretary, your plans to be present at this interview. You may contact Mrs. Ellis at mellis@albme.gov or at 334-242-4116.

(Board Ex. 13.)

13. Respondent appeared for an interview before the Credentials Committee of the Board on November 13, 2024. (Board Ex. 14.) Respondent failed to provide any documentation relating to CRH's claim against him either before or at his Credentials Committee interview. When asked why, Respondent responded that it had been so long ago that he no longer had any documents. When asked why he did not provide the documents when the Board requested them in 2014 and 2015, he protested that he did not have an Alabama license at those times and was not seeking an Alabama license at those times.

#### III. Conclusions of Law

- 1. The Medical Licensure Commission of Alabama has jurisdiction over the subject matter of this cause pursuant to Act No. 1981-218, Ala. Code §§ 34-24-310, et seq. Under certain conditions, the Commission "shall have the power and duty to suspend, revoke, or restrict any license to practice medicine or osteopathy in the State of Alabama or place on probation or fine any licensee." Ala. Code § 34-24-360.
- 2. The Commission also has power to order reinstatement, or, in appropriate circumstances, to deny reinstatement, of licenses to practice medicine in Alabama. If the Board demonstrates any violation of Ala. Code § 34-24-360, the Commission has discretion to deny reinstatement. See Ala. Code § 34-24-337(h) ("The commission may deny reinstatement of a license upon a finding that the applicant has committed any of the acts or offenses set forth in Sections 34-24-360, 34-24-57, 16-47-128, or any other provision of law establishing grounds for the revocation, suspension, or discipline of a license to practice medicine.").
- 3. Respondent was properly notified of the time, date and place of the administrative hearing and of the charges against him in compliance with Ala. Code §§ 34-24-361(e) and 41-22-12, and Ala. Admin. Code r. 545-X-3-.03(3), (4). At all relevant times, Respondent was a licensee of this Commission and/or an applicant

for reinstatement of a license to be issued by the Commission and was and is subject to the Commission's jurisdiction.

- 4. Before making any decision on a contested case such as this one, the Commission is required by law to "receive and consider" a recommendation from the Board. The Board's recommendation, however, is not binding upon the Commission. See Ala. Code § 34-24-361(h). The Commission has received and duly considered the Board's non-binding recommendation to find Respondent guilty of unprofessional conduct and to deny Respondent's application for license reinstatement.
- 5. Section 34-24-360(2), Alabama Code 1975, prohibits physicians from engaging in "[u]nprofessional conduct as defined . . . in the rules and regulations promulgated by the Commission." The Commission's rules, in turn, define "unprofessional conduct" to include "[f]ailing to furnish information in a timely manner to the Board or Commission if requested by the Board or Commission." Ala. Admin. Code r. 545-X-4-.06(19).
- 6. The evidence before the Commission clearly substantiates that Respondent is guilty of unprofessional conduct as defined in Ala. Admin. Code r. 545-X-4-.06(19). Denial of license reinstatement is the only proper response.
- 7. We reach all of these decisions based on all of the facts presented, viewed through the lens of our professional experience, expertise, and judgment. See

Ala. Code § 41-22-13(5) ("The experience, technical competence, and specialized knowledge of the agency may be utilized in the evaluation of the evidence.").

### IV. Decision

Based on all of the foregoing, it is ORDERED, ADJUDGED, AND DECREED:

- 1. That the Respondent, Kamaledin Hassan Kamal, M.D., is adjudged GUILTY of Unprofessional Conduct as charged in Count One of the Administrative Complaint; and
- 2. That Respondent's application for reinstatement of his license to practice medicine in the State of Alabama is **DENIED**.
