The Board of Medical Examiners, at its meeting September 18, 2025, approved the following rule to be published for public comment in the *Alabama Administrative Monthly*:

• Administrative Rule 540-X-8-.01, *Definitions (Advanced Practice Nurses: Collaborative Practice)*

In the most recent legislative session, the Alabama Legislature passed Act No. 2025-378, which amended Ala. Code § 34-21-81 and 34-21-82 and revised the composition of the Joint Committee of the State Board of Medical Examiners and the Board of Nursing for Advanced Practice Nurses. The proposed revised rule reflects this change.

With an expected publication date of September 30, 2025, the public comment period ends November 4, 2025. The anticipated effective date January 10, 2026.

540-X-8-.01 Definitions.

The following definitions will apply to these rules:

- (1) BOARD OF MEDICAL EXAMINERS. The State Board Of Medical Examiners established pursuant to Code of Ala. 1975, §34-24-53.
- (2) BOARD OF NURSING. The Board of Nursing established under $\underline{\text{Code}}$ of Ala. 1975, §34-21-2.
- (3) ADVANCED PRACTICE NURSE. A registered nurse who has gained additional knowledge and skills through successful completion of an organized program of nursing education that prepares nurse for advanced practice roles and has been approved by the Board of Nursing to engage in the practice of advanced practice nursing. Two categories of advanced practice nurses are subject to the requirements of collaborative practice:
 - (a) Certified registered nurse practitioners (CRNP)
 - (b) Certified nurse midwives (CNM)
- (4) ADVANCED PRACTICE NURSING COLLABORATIVE PRACTICE. The delivery of health care services by registered nurses who have gained additional knowledge and skills through successful completion of an organized program of nursing education that prepares nurses for advanced practice roles as certified registered nurse practitioners or certified nurse midwives:
 - (a) Practice as a certified registered nurse practitioner (CRNP) is the performance of nursing skills by a registered nurse who has demonstrated by certification advanced knowledge and skills in the delivery of nursing services within a health care system that provides for consultation, collaborative management or referral as indicated by the health status of the client.
 - (b) Practice as a certified nurse midwife (CNM) is the performance of nursing skills by a registered nurse who has demonstrated by certification advanced knowledge and skills relative to the management of women's health care focusing on pregnancy, childbirth, the post-partum period, care of the newborn, family planning and gynecological needs of women, within a health care system that provides for consultation, collaborative management or referral as indicated by the health status of the client.
- (5) COLLABORATION. A formal relationship between one or more certified registered nurse practitioners or certified nurse midwives and a physician or physicians under which these nurses

may engage in advanced practice nursing as evidenced by written protocols approved according to the requirements of Code of Ala. 1975, \$\$34-21-80, et. seq. or exempted according to requirements of this statute. The term collaboration does not require direct, on-site supervision of the activities of a certified registered nurse practitioner or a certified nurse midwife by the collaborating physician. The term does require such medical oversight and direction as required by the rules and regulations of the Board of Nursing and the State Board of Medical Examiners.

- (6) PHYSICIAN OR COLLABORATING PHYSICIAN. A doctor of medicine or a doctor of osteopathy licensed to practice medicine in Alabama who agrees in writing to practice in collaboration with one or more certified registered nurse practitioners or certified nurse midwives according to the rules and regulations adopted by the Board of Nursing and the State Board of Medical Examiners.
- (7) JOINT COMMITTEE OF THE BOARD OF NURSING AND THE STATE BOARD OF MEDICAL EXAMINERS FOR ADVANCED PRACTICE NURSES. The Joint Committee of the Board of Nursing and the State Board of Medical Examiners for Advanced Practice Nurses is a committee composed of the following, pursuant to Code of Ala. 1975, §34-21-80 et seq.
 - (a) Two physicians licensed to practice medicine in the State of Alabamathis state;
 - (b) One registered nurse licensed to practice professional nursing in the State of Alabama;
 - (c) One licensed physician engaged in collaborative practice with a certified registered nurse practitioner or a certified nurse midwife in the State of Alabamathis state;
 - (d) One(c) Two certified registered nurse
 practitioners engaged in advancedan active
 collaborative practice nursing with a physician in the State
 of Alabamathis state; and
 - (e) One certified nurse midwife engaged in advanced an active collaborative practice with a physician in the State of Alabamathis state.
- (8) LEGEND DRUG. Any drug, medicine, chemical or poison bearing on the label the words, "Caution, federal law prohibits dispensing without prescription" or similar words indicating that such drug, medicine, chemical, or poison may be sold or dispensed only upon the prescription of a licensed practitioner, except that the term legend drug will not include any drug, substance, or compound which is listed Schedules I through V of the Alabama Uniform Controlled Substances Act.

- (9) PRESCRIBE OR PRESCRIBING. The act of issuing a prescription for a legend drug.
- (10) PRESCRIPTION. An order for a legend drug which is issued and signed by a practitioner authorized by law to prescribe and administer such drugs and is intended to be filled, compounded, or dispensed by a pharmacist.
- (11) PROTOCOL. A document approved according to <u>Code of Ala.</u> 1975, §34-21-81, establishing the permissible functions and activities to be performed by certified registered nurse practitioners and certified nurse midwives and signed by collaborating physicians and any nurse practitioners or nurse midwives practicing with those physicians.
- (12) MEDICAL OVERSIGHT. Concurrent and on-going collaboration between a physician and a CRNP or CNM and documentation of time together in a practice site; may include but is not limited to direct consultation and patient care, discussion of disease processes and medical care, review of patient records, protocols and outcome indicators, and other activities to promote positive patient outcomes.
- (13) QUALITY ASSURANCE. Documented evaluation of the clinical practice of the certified registered nurse practitioner or certified nurse midwife against defined quality outcome measures, using a selected, meaningful sample of patient records which will identify areas needing improvement, set performance goals, and assess progress towards meeting established goals, with a summary of findings, conclusions, and, if indicated, recommendations for change. The physician's signature on the patient record does not constitute quality improvement monitoring.
- (14) PRINCIPAL PRACTICE SITE. The main location at which the collaborating physician is engaged in the practice of medicine.
- (15) REMOTE PRACTICE SITE. An approved site for collaborative practice without a collaborative or covering physician on-site. The collaborating physician's principal practice site, acute care hospitals, skilled nursing facilities, licensed, special-care assisted living facilities and licensed assisted living facilities are not remote practice sites for the purpose of these rules.
- (16) READILY AVAILABLE. Response by the collaborating or covering physician by telephone or telecommunication for consultation, referral or direct medical intervention for a patient as indicated by the needs of a patient and based on usual and customary standards of medical practice.

- (17) DIRECT MEDICAL INTERVENTION. Physical presence of a physician to attend the patient as defined in the collaborative practice protocol.
- (18) COVERING PHYSICIAN. A doctor of medicine or a doctor of osteopathy licensed to practice medicine in Alabama who agrees in writing to be readily available to collaborate with and provide medical oversight to one or more certified registered nurse practitioners or certified nurse midwives and, if indicated, to provide direct medical intervention to patients during the absence of the Collaborating Physician. The covering physician shall be either a member of the same medical practice, practice group, or multidisciplinary medical team, or of the same or similar practice specialty as the collaborating physician and shall abide by the rules and regulations adopted by the Board of Nursing and the Board of Medical Examiners.

• Administrative Rule 540-X-23-.01, Definitions (Physician Reentry into Practice)

The proposed rule amends the Board's Physician Reentry Rule 540-X-3, to explicitly state that "active clinical practice" should refer only to practice contained within any jurisdiction of the U.S. or Canada, including territories.

With an expected publication date of September 30, 2025, the public comment period ends November 4, 2025. The anticipated effective date January 10, 2026.

540-X-23-.01 Definitions.

- (1) Active Practice: A physician may be said to be in active clinical practice when any amount of direct patient care has been provided during the preceding two years in any jurisdiction of the United States or Canada, including territories.
- (2) Direct Patient Care: Direct patient care has been provided when a physician treats, or professes to diagnose, treat, perform surgery on, or prescribe medication to a patient for any physical ailment or injury in a clinical or professional setting.
- (3) Burden of Proof: The reentry candidate shall have the burden of providing appropriate proof of direct patient care. Ideally, such proof will include a patient chart but may include other documentation as deemed appropriate by the Board.
- (4) Two-Year Period: The beginning of the two-year period will begin from the date the physician last provided direct patient care and will be tolled by the filing of an initial or reinstatement application for a certificate of qualification to practice medicine or a medical license reinstatement application.
- (5) Board: Alabama Board of Medical Examiners
- (6) Commission: Medical Licensure Commission of Alabama

The Board has probable cause to believe that grounds exist for the denial of the application for reinstatement and will exhibit the same in its forthcoming Administrative Complaint.

The Board requests that a hearing be scheduled before the Medical Licensure Commission prior to a decision regarding the reinstatement of Respondent's license to practice medicine in Alabama.

CONSENT DECREE

This matter comes before the Medical Licensure Commission of Alabama ("the Commission") on the Administrative Complaint ("the Administrative Complaint") filed by the Alabama State Board of Medical Examiners ("the Board") on September 16, 2025. The Board and the Respondent, Kareem Hamdy Bedeir, M.D. ("Respondent"), have entered into a Joint Settlement Agreement ("the Settlement Agreement"), and have asked the Commission to approve the Settlement Agreement and to embody it in this Consent Decree.

General Provisions

1. <u>Approval of the Settlement Agreement</u>. After review, the Commission finds that the Settlement Agreement represents a reasonable and appropriate disposition of the matters asserted in the Administrative Complaint. The Commission therefore approves the Settlement Agreement.

- 2. Mutual Agreement and Waiver of Rights. Respondent has consented and agreed to the entry of this Consent Decree, and has agreed to be bound by the findings of fact, conclusions of law, and terms and conditions stated herein. Respondent has validly waived all rights to an administrative hearing before the Commission, to be represented by an attorney at such hearing, and to further notice and formal adjudication by the Commission of the charges arising from the Administrative Complaint. Respondent has also validly waived all rights to judicial review of this Consent Decree pursuant to Ala. Code § 34-24-367, the Alabama Administrative Procedure Act, Ala. Code §§ 41-22-1, et seq., by extraordinary writ, or otherwise.
- 3. <u>Public Documents</u>. The Administrative Complaint, the Settlement Agreement, and this Consent Decree shall constitute public records under the laws of the State of Alabama. The Administrative Complaint, the Settlement Agreement, and this Consent Decree may be published or disclosed by the Board and/or the Commission without further notice to Respondent.
- 4. <u>Additional Violations</u>. Any violation of the requirements of this Consent Decree, or any new violation of state or federal laws or regulations, may result in the Board filing a petition to discipline Respondent's medical license. Nothing in this Consent Decree precludes the Board from bringing new

administrative charges against Respondent based upon events and circumstances not raised in the Administrative Complaint.

- 5. Retention of Jurisdiction. The Commission retains jurisdiction for the purpose of entering such other and further orders and directives as may be required to implement the provisions of this Consent Decree.
- 6. Official Notice. Pursuant to Ala. Code § 41-22-13(4), Respondent is informed that the Board and/or the Commission may at any time take official notice of this Consent Decree, and/or any of the Findings of Fact herein, and may deem any of the findings or conclusions set forth in this Consent Decree to be conclusively established, all without further notice to Respondent.

Findings of Fact

- 1. Respondent has been licensed to practice medicine in the State of Alabama since June 24, 2020, having been issued license no. MD.40928. Respondent was so licensed at all relevant times.
- 2. On or about November 6, 2024, Respondent submitted or caused to be submitted an Alabama medical license renewal application for calendar year 2025. On that application, Respondent certified that the annual minimum continuing medical education requirement of 25 AMA PRA Category 1TM credits had been met or would be met by December 31, 2024. Respondent further represented that, if audited, Respondent would have supporting documents.

3. Respondent did not earn any valid continuing medical education credits during 2024.

Conclusions of Law

- 1. The Commission has jurisdiction over the subject matter of the Administrative Complaint, and over the parties, pursuant to Ala. Code § 34-24-310, et seq.
- 2. The Commission finds, as a matter of law, that the determined facts constitute violations of Ala. Code § 34-24-360(23), Ala. Admin. Code r. 545-X-5-.02, and Ala. Admin. Code r. 545-X-5-.10.

Order/Discipline

Based upon the foregoing Findings of Fact and Conclusions of Law, it is ORDERED, ADJUDGED, AND DECREED:

1. That Respondent is assessed an administrative fine in the amount of two thousand five hundred dollars (\$2,500.00). In accordance with Ala. Admin. Code r. 545-X-3-.08(8)(d)(i), Respondent is ordered to pay the administrative fine within 30 days of this Order.¹

¹ See Ala. Admin. Code r. 545-X-3-.08(8)(d)(i). Respondent is further advised that "[t]he refusal or failure by a physician to comply with an order entered by the Medical Licensure Commission" may be a separate instance of "unprofessional conduct." See Ala. Admin. Code r. 545-X-4-.06(6). Failure to timely pay the assessed costs and fines may therefore form an independent basis for further disciplinary action against Respondent.

- 2. That Respondent is ordered to obtain 25 *additional* credits of AMA PRA Category 1TM or equivalent continuing medical education, in addition to the 25 credits already required for calendar year 2025, for a combined total of 50 credits, during calendar year 2025.
- 3. That no costs of this proceeding are assessed against Respondent at this time.

FIRST AMENDED ADMINISTRATIVE COMPLAINT

The Alabama State Board of Medical Examiners (hereinafter "the Board"), by and through its counsel, hereby submits this First Amended Administrative Complaint seeking to reprimand, restrict, revoke or sanction the medical license of COSMIN DOBRESCU, M.D. (hereinafter "Respondent") under Ala. Code § 34-24-361(e).

JURISDICTION

1. On or about August 14, 2018, Respondent was issued license number MD.37367, to practice medicine in the state of Alabama and was licensed at all times material to this complaint. On May 24, 2023, the Medical Licensure Commission ("the Commission") took jurisdiction of an administrative complaint filed by the Board against Respondent in the above-styled matter. The Board moved for the summary suspension of Respondent's medical license contemporaneously with the filing of the Administrative Complaint. The Commission suspended Respondent's medical license, and the suspension remains in place following the effective waiver of Respondent's right to a hearing within 120 days of the suspension.

FACTS

2. On or about February 21, 2023, the Board received information from the Alaska Division of Corporations, Business and Professional Licensing through the Physician Data Center

(PDC) disclosing the summary suspension of Respondent's temporary practice permit on February 10, 2023.

- 3. Respondent is a board certified thoracic and cardiac surgeon. Respondent provided locums services at Alaska Regional Hospital in Anchorage, Alaska. In August 2022, Respondent applied for a full medical license. Respondent also obtained a temporary practice permit, identified as Alaska Physician Temporary Permit 199122, while his full application was pending. On or about December 8, 2022, Respondent recommended and performed a coronary artery bypass grafting and surgical aortic valve replacement ("CABG/SAVR") on a 73-year-old patient, identified as Patient D.M. The surgery went poorly, and patient D.M. died on the operating table that same evening.
- 4. The anesthesia physicians assisting Respondent with this surgery reported him for misconduct to the Alaska State Medical Board (the "Alaska Board"). On or about February 10, 2023, the Alaska Board summarily suspended Respondent's temporary practice permit. Due to legal proceedings in Alaska, a final determination on the Alaska Board action did not occur until April 2025. A full hearing was held over eleven days, concluding on April 2, 2025.
- 5. On or about May 16, 2025, the Alaska Board adopted the order of its administrative law judge. The Alaska Board revoked Respondent's temporary permit and affirmed its February 10, 2023, summary suspension of that permit. In the order, the Alaska Board found that "the following circumstances were true in February 2023:"
 - a. Respondent obtained his temporary permit by fraud;
 - b. Respondent "fraudulently concealed" information that he was under active investigation in the state of Virginia at the time he submitted his application for licensure in Alaska;
 - c. Respondent misstated other facts in his application, "rendering the application broadly unreliable;"

- d. "Within weeks of starting to practice in Alaska, [Respondent] used substandard judgment in taking a patient to surgery, and the patient's subsequent death on the operating table was substantially related to the substandard preoperative risk evaluation;"
- e. "After losing a patient in this matter, [Respondent] exhibited deeply irresponsible behavior by failing to provide an operative report;" and
- f. "[Respondent] operates in a high-risk, unforgiving specialty where errors can and do have fatal consequences."
- 6. The Alaska Board found that the presence of these facts showed that Respondent's continued licensure posed a "clear and immediate danger to the health and safety of [the Alaskan patient] population."

CHARGES

7. The Board has investigated Respondent and concluded that there is probable cause to believe that he has violated Ala. Code § 34-24-360.

COUNT ONE - DISCIPLINARY ACTION TAKEN BY ANOTHER STATE

8. On or about February 10, 2023, the Alaska State Medical Board entered an order summarily suspending the temporary practice permit of COSMIN DOBRESCU, M.D. after finding that his continued practice of medicine posed a clear and immediate danger to the health and safety of Alaskan patients, said suspension constituting disciplinary action in another state based upon acts similar to the acts described in Ala. Code § 34-24-360, in violation of Ala. Code § 34-24-360(15).

COUNT TWO - DISCIPLINARY ACTION TAKEN BY ANOTHER STATE

9. On or about May 16, 2025, the Alaska State Medical Board entered an order revoking the temporary practice permit of COSMIN DOBRESCU, M.D. after finding that he obtained the permit by fraud, said revocation constituting disciplinary action in another state based

upon an act similar to an act described in Ala. Code § 34-24-360, in violation of Ala. Code § 34-24-360(15).

COUNT THREE – PRACTICING MEDICINE IN SUCH A MANNER AS TO ENDANGER THE HEALTH OF A PATIENT

10. On or between December 8, 2022 and February 10, 2023, COSMIN DOBRESCU, M.D. practiced medicine in such a manner as to endanger the health of a patient, specifically, Patient D.M., in violation of Ala. Code § 34-24-360(3).

COUNT FOUR – GROSS MALPRACTICE AND GROSS NEGLIGENCE IN THE PRACTICE OF MEDICINE

11. On or between December 8, 2022 and February 10, 2023, COSMIN DOBRESCU, M.D. committed gross malpractice and gross negligence in the practice of medicine when he used substandard judgment in taking Patient D.M. to surgery, said decision to proceed with surgery occurring in contravention of known factors that would have led a reasonably prudent physician in the same or similar circumstances to make a different decision, in violation of Ala. Admin. Code r. 545-X-1-.11(l) and Ala. Code § 34-24-360(9).

COUNT FIVE - UNPROFESSIONAL CONDUCT

12. Beginning on or about December 9, 2022, COSMIN DOBRESCU, M.D. committed unprofessional conduct in the practice of medicine when he failed to provide a timely operative report following the death of Patient D.M., in violation of Ala. Code § 34-24-360(2).

COUNT SIX - UNPROFESSIONAL CONDUCT

13. In or about August, 2022, COSMIN DOBRESCU, M.D. committed unprofessional conduct in the practice of medicine when obtained a medical license in Alaska by fraud, said conduct being dishonorable and showing a disposition to lie, cheat, and defraud, in violation of Ala. Code § 34-24-360(2).

WHEREFORE, the foregoing premises considered, the Board respectfully moves the Medical Licensure Commission to set a hearing on this First Amended Administrative Complaint, and order that COSMIN DOBRESCU, M.D. appear and answer the allegations contained in this First Amended Administrative Complaint. The Board requests that, at the conclusion of the hearing, the Commission reprimand, restrict, revoke or sanction the license to practice medicine of Respondent, assess the maximum fine, and/or take such other action as the Commission may deem appropriate based upon the evidence presented for consideration.

The Board is continuing the investigation of Respondent. Said investigation may result in additional charges being prepared and filed as an amendment to this First Amended Administrative Complaint.

The Board requests that administrative costs be assessed against Respondent pursuant to Ala. Code § 34-24-381 and Commission Rule 545-X-3-.08(12)(e).

FINDINGS OF FACT AND CONCLUSIONS OF LAW

This matter came before the Medical Licensure Commission of Alabama for a contested case hearing on September 25, 2025. After receiving and considering all of the relevant evidence and argument, we find the Respondent, Gregory Keith Parker, M.D., guilty of the four disciplinary charges presented by the Board and impose professional discipline as outlined below.

I. Introduction and Procedural History

The Respondent in this case is Gregory Keith Parker, M.D. ("Respondent"). Respondent is a licensee of this Commission who was first licensed on June 30, 1984, having been issued license no. MD.11523.

This case began with an Administrative Complaint and Petition for Summary Suspension of License ("the Administrative Complaint") filed by the

Board with the Commission on or about June 17, 2025. The Administrative Complaint contains four counts.

In Count One, the Board alleges that professional discipline is warranted because Respondent's clinical privileges at Mobile Infirmary were suspended for reasons relating to professional competence and disruptive behavior, in violation of Ala. Code § 34-24-360(18). Count Two alleges that Respondent is unable to practice medicine with reasonable skill and safety to patients by reason of illness or a mental or physical condition, in violation of Ala. Code § 34-24-360(19)a. Counts Three and Four of the Administrative Complaint accuse Respondent of unprofessional conduct in transgression of Ala. Code § 34-24-360(2) and Ala. Admin. Code r. 545-X-4-.06. As grounds for the unprofessional conduct claims, Count Three alleges that Respondent failed or refused to comply with a Board order directing him to submit to a neuropsychiatric evaluation at , and Count Four alleges that Respondent entered progress notes in several patients' electronic medical records that were materially false in that Respondent had neither seen nor examined those patients.

On these four grounds, the Board urges the Commission to "revoke the license to practice medicine of Respondent, assess the maximum fine, and/or take such other actions as the Commission may deem appropriate based upon the evidence presented for consideration."

In accordance with Ala. Code § 34-24-361(f) and Ala. Admin. Code r. 545-X-3-.13(1)(a), on June 25, 2025, we entered an order summarily suspending Respondent's license to practice medicine and set this matter for a full evidentiary hearing.

On September 25, 2025, we conducted a full evidentiary hearing as prescribed in Ala. Admin. Code r. 545-X-3. The case supporting disciplinary action was presented by the Alabama Board of Medical Examiners through its attorneys E. Wilson Hunter and Alicia Harrison. Respondent did not appear, and the hearing was held in absentia as authorized in Ala. Code §§ 34-24-361(e)(10) and 41-22-12(d). Pursuant to Ala. Admin. Code r. 545-X-3-.08(1), the Honorable William R. Gordon presided as Hearing Officer. Each side was offered the opportunity to present evidence and argument in support of its respective contentions, and to cross-examine the witnesses presented by the other side (though Respondent, as noted above, declined this opportunity). Board Exhibits 1, 3-9, and 11-17 were received into evidence. After careful review, we have made our own independent judgments regarding the weight and credibility to be afforded to the evidence, and the fair and reasonable inferences to be drawn from it. Having done so, and as prescribed in Ala. Code § 41-22-16, we enter the following Findings of Fact and Conclusions of Law.

II. **Findings of Fact**

- 1. Respondent was first licensed to practice medicine in Alabama on June 30, 1984, under license number MD.11523. Respondent most recently practiced medicine as an internal medicine physician in Mobile, Alabama with admitting privileges at Mobile Infirmary Medical Center ("Mobile Infirmary").
- 2. Mobile Infirmary suspended Respondent's privileges on February 19, 2025. The suspension of Respondent's privileges was reported to the Board, and the Board opened its own investigation.
- 3. Board Investigator Stephen Lavender was assigned to serve formal notice of the Board's investigation upon Respondent. Investigator Lavender made several attempts to communicate with Respondent via telephone and e-mail about the investigation and to make arrangements for formal service. Respondent did not respond to Investigator Lavender's communications. On March 10, 2025, Investigator Lavender sent a fifth e-mail to Respondent, urging him to cooperate with the Board's investigation. (Board Ex. 3.)
- 4. On March 11, 2025, Investigators Lavender and Schlemmer traveled to Mobile, Alabama in an effort to find Respondent and serve him with notice of the Board's investigation. The investigators found Respondent at his practice location of record, 1308 Old Shell Road. After the investigators identified themselves to Respondent and told him why they were there, Respondent refused

to accept service of any papers and told them to leave. Respondent said, "Get out of here, I'm going to call the police." Respondent also made statements to the effect that he knew that the investigators were armed and that he had a weapon as well. Concerned for their own safety, the investigators left the area.

5. On April 4, 2025, the Board entered the following Order:

ORDER

The Alabama State Board of Medical Examiners ("the Board"), having considered information concerning the suspension of GREGORY KEITH PARKER, M.D.'s privileges at Mobile Infirmary Medical Center due to patient care concerns and behavior which could result in imminent danger to the health and safety of individuals, has concluded that there is probable cause to believe that GREGORY KEITH PARKER, M.D. is not capable, physically or mentally, of practicing medicine with reasonable skill and safety to patients.

Accordingly, it is the ORDER of the Board, pursuant to its authority under Ala Code § 34-24-360(19)a, that GREGORY KEITH PARKER, M.D. submit to a complete neuropsychiatric evaluation at

Dr. Parker should accept

first available appointment and complete the evaluation within 45 days of the date of this Order.

The Board further ORDERS that the results of this evaluation be forwarded to the Board for review and that GREGORY KEITH PARKER, M.D. sign a release for the medical director and professionals at to forward such results and communicate with the Board regarding the results and any other information concerning the evaluation. The expense of the evaluation ordered herein shall be borne by GREGORY KEITH PARKER, M.D.

GREGORY KEITH PARKER, M.D. is ORDERED and DIRECTED to confirm whether he intends to comply with this order by notifying the Board's Physician Monitoring Director, Roland Johnson (rjohnson@albme.gov), or Legal Assistant, Lynde Crowder (lcrowder@albme.gov), at (334) 242-4116 or 1-800-227-2606, NO LATER THAN April 21, 2025. Dr. Parker is further ordered to notify Roland Johnson or Lynde Crowder of the date of the scheduled evaluation.

ORDERED this 4th day of April, 2025.

(Board Exhibit 5 (boldface in original).)

- 6. Investigator Lavender and the Board's Physician Monitoring Director, Roland Johnson, made three attempts to serve the Board's April 4, 2025 Order upon Respondent. On April 8, 2025, with the assistance of the Mobile County Sheriff's Office, Lavender and Johnson made contact with Respondent at a Mobile-area bank. The investigators handed the Board's Order to Respondent, and Respondent threw the papers on the hood of the investigators' vehicle and began to walk away. The investigators followed Respondent into the bank and tucked the papers under Respondent's arm. Respondent dropped the papers to the floor.
- 7. Respondent apparently scheduled an appointment for the Board-ordered evaluation at for May 12 or 14, 2025, but failed to pay the deposit and did not appear for the evaluation.

- 8. The Commission received testimony from Dr. Barbara Mitchell, M.D., who is an internist at Mobile Infirmary and currently serves as its Vice President of Medical Staff. Dr. Mitchell has been a colleague of Respondent's since 1996 or 1997. She described his personality over the years as fun-loving and affable, if a bit quirky at times. In recent months, however, Dr. Mitchell began to observe instances of concerning behavior by Respondent. In December 2024 or January 2025, Dr. Mitchell phoned Respondent to ask him if he was okay; he said he could not talk at that moment and abruptly ended the call. At about 2:00 a.m. the next morning, Respondent phoned Dr. Mitchell and began making implausible statements involving Mobile Infirmary's Chief Executive Officer and the Mobile Police Department. Respondent said that he could not go into further detail because the FBI and CIA were monitoring his calls, and that they would "come after" him if he elaborated further. According to Dr. Mitchell, Respondent seemed either not to be aware, or not to find it unusual, that he was calling her at 2:00 a.m.
- 9. Based on her personal observations, Dr. Mitchell testified that she was very concerned about Respondent's ability to practice medicine with reasonable skill and safety to patients.
- 10. Based on this and other concerning behavior by Respondent, Mobile Infirmary's Peer Review Committee was convened. During these meetings, Respondent continued to display angry, erratic, and delusional behavior. As noted

above, on February 19, 2025, Mobile Infirmary suspended Respondent's clinical privileges. On the morning of February 20, 2025, therefore, Respondent did not have privileges to see patients at the hospital.

- 11. The Commission also received testimony from Dr. Wendell Erdman,M.D. Dr. Erdman holds the titles of President of Medical Staff and HospitalistMedical Director at Mobile Infirmary.
- 12. Dr. Erdman practices at Mobile Infirmary as a hospitalist trained in internal medicine and pediatrics, and has known Respondent professionally for about 25 years. Until recently, Dr. Erdman never had concerns about Respondent's ability to practice medicine with reasonable skill and safety, although he noted that Respondent could be "eccentric" at times.
- 13. In the early morning hours of February 20, 2025, Mobile Infirmary's security department notified Dr. Erdman that Respondent was in the Emergency Room working in "Epic," the hospital's electronic medical record system. Dr. Erdman went to the Emergency Room, sat down next to Respondent, and explained to him that he did not hold privileges and therefore could not see patients or access Epic. Respondent protested that Dr. Erdman was trying to "embarrass" him. After more conversation, Dr. Erdman finally convinced Respondent to leave and to attend an appointment with an occupational health

provider. Dr. Erdman made the occupational health appointment for Respondent, but Respondent did not appear for the appointment.

- 14. Dr. Erdman reviewed Respondent's activity in Epic and identified progress notes made by Respondent in the records of at least three patients—B.T., R.R., and V.B.—all of which represented that Respondent had seen those patients in the morning hours of February 20, 2025. (Board Ex. 13 at 101-103; Board Ex. 14 at 89-91; Board Ex. 15 at 69-70.) Dr. Erdman asked all three patients if they had seen Respondent that morning, and all three responded in the negative. Moreover, two of the three said they had not seen Respondent all week. The progress notes made by Respondent were not "drafts"; they were finalized and authenticated electronic notes purporting to document patient encounters that had never happened.
- 15. Dr. Erdman testified that Respondent has become more erratic, explosive, and angry to the extent that he has concerns about Respondent's ability to practice medicine with reasonable skill and safety to patients.
- 16. The Commission received testimony from Dr. William Admire, Jr., D.O., the Chief Medical Officer for the three hospitals in the Infirmary System. Dr. Admire has known Respondent for approximately 30 years and has long considered him a friend and colleague. In late 2024 and early 2025, Dr. Admire learned of erratic, unprofessional, and uncooperative behavior by Respondent.

When Dr. Admire phoned Respondent to check on him, Respondent admitted that he had been sitting in his front yard holding a shotgun because he was worried about people coming after him. Respondent expressed other paranoid thoughts and behaviors to Dr. Admire. Dr. Admire testified that he was "very concerned" that Respondent's continued practice of medicine would constitute a danger to the public.

III. Conclusions of Law

- 1. The Medical Licensure Commission of Alabama has jurisdiction over the subject matter of this cause pursuant to Act No. 1981-218, Ala. Code §§ 34-24-310, et seq. Under certain conditions, the Commission "shall have the power and duty to suspend, revoke, or restrict any license to practice medicine or osteopathy in the State of Alabama or place on probation or fine any licensee." Ala. Code § 34-24-360.
- 2. Respondent was properly notified of the time, date and place of the administrative hearing and of the charges against him in compliance with Ala. Code §§ 34-24-361(e) and 41-22-12, and Ala. Admin. Code r. 545-X-3-.03(3), (4). At all relevant times, Respondent was a licensee of this Commission and was and is subject to the Commission's jurisdiction.

- 3. Before making any decision on a contested case such as this one, the Commission is required by law to "receive and consider" a recommendation from the Board. The Board's recommendation, however, is not binding upon the Commission. See Ala. Code § 34-24-361(h). The Commission has received and duly considered the Board's non-binding recommendation to find Respondent guilty of the four disciplinary charges outlined in the Administrative Complaint and to "revoke the license to practice medicine of Respondent, assess the maximum fine, and/or take such other actions as the Commission may deem appropriate based upon the evidence presented for consideration."
- 4. Under Alabama law, the "Commission shall have the power and duty to suspend, revoke, or restrict any license to practice medicine or osteopathy in the State of Alabama . . . whenever the licensee shall be found guilty on the basis of substantial evidence of . . . [t]he termination, revocation, probation, restriction, denial, failure to renew, suspension, reduction, or resignation of staff privileges of a licensee by a hospital in this or any other state when such action is related to negligence or incompetence in the practice of medicine, moral turpitude, sexual misconduct, abusive or disruptive behavior, or drug or alcohol abuse." Ala. Code § 34-24-360(18). The evidence before the Commission substantiates that on February 19, 2025, Respondent's clinical privileges at Mobile Infirmary were suspended for reasons related to negligence or incompetence in the practice of

medicine, and/or abusive or disruptive behavior, in violation of Ala. Code § 34-24-360(18).

- 5. The Commission likewise has the power and duty to suspend, revoke, or restrict any license to practice medicine or osteopathy in the State of Alabama when it is shown, after notice and hearing, that the physician is "unable to practice medicine or osteopathy with reasonable skill and safety to patients by reason of illness, inebriation, excessive use of drugs, narcotics, alcohol, chemicals, or any other substance, or as a result of any mental or physical condition." Ala. Code § 34-24-360(19)a. The evidence before the Commission substantiates that Respondent is currently unable to practice medicine with reasonable skill and safety to patients by reason of illness or a mental or physical condition, contrary to Ala. Code § 34-24-360(19)a.
- 6. Counts Three and Four accuse Respondent of unprofessional conduct. The Commission may discipline any physician who, after notice and hearing, is shown to have engaged in "[u]nprofessional conduct as defined herein or in the rules and regulations promulgated by the Commission." Ala. Code § 34-24-360(2).
- 7. The Commission has specifically defined a physician's failure or refusal to submit to an examination ordered by the Board pursuant to Ala. Code § 34-24-360(19) as "unprofessional conduct" punishable by the Commission:

Unprofessional conduct shall mean the [c]ommission or omission of any act that is detrimental or harmful to the patient of the physician or detrimental or harmful to the health, safety, and welfare of the public, and which violates the high standards of honesty, diligence, prudence and ethical integrity demanded from physicians and osteopaths licensed to practice in the State of Alabama. Furthermore, without limiting the definition of unprofessional conduct in any manner, the Commission sets out the below as examples of unprofessional conduct:

* * *

(6) The refusal or failure by a physician to comply with an order entered by . . . the Board of Medical Examiners issued pursuant to Code of Ala. 1975, Section 34-24-360(19) or (20) or pursuant to Code of Ala 1975, Section 34-24-361(h).

Ala. Admin. Code r. 545-X-4-.06(6) (emphasis added).

- 8. It is undisputed that Respondent failed to obey the Board's Order of April 4, 2025. That disobedience is "unprofessional conduct" under Ala. Code § 34-24-360(2) and Ala. Admin. Code r. 545-X-4-.06(6) as alleged in Count Three of the Administrative Complaint.
- 9. The Commission has further defined "unprofessional conduct" to include the act of "[i]ntentionally, knowingly or willfully causing or permitting a false or misleading representation of a material fact to be entered on any medical record of a patient." Ala. Admin. Code r. 545-X-4-.06(2). The evidence before the Commission substantiates that Respondent knowingly made false representations of material facts in the medical records of at least three patients,

B.T., R.R., and V.B., in violation of Ala. Code § 34-24-360(2) and Ala. Admin. Code r. 545-X-4-.06(2).

- Respondent's paranoid beliefs and disruptive behavior, the suspension of Respondent's hospital privileges on February 19, 2025, his finalized but untrue progress notes for at least three patients on February 20, 2025, and his failure to comply with the Board's April 4, 2025 Order requiring a neuropsychiatric evaluation—demonstrates both an immediate risk to patient safety and the Respondent's inability or unwillingness to comply with progressive remedial measures. We therefore find that less drastic remedies would not sufficiently protect the public and that revocation of Respondent's license is necessary and appropriate under Ala. Code § 34-24-360.
- 11. We reach all of these decisions based on all of the facts presented, viewed through the lens of our professional experience, expertise, and judgment. See Ala. Code § 41-22-13(5) ("The experience, technical competence, and specialized knowledge of the agency may be utilized in the evaluation of the evidence.").

IV. Decision

Based on all of the foregoing, it is **ORDERED**, **ADJUDGED**, **AND DECREED**:

- 1. That the Respondent, Gregory Keith Parker, M.D., is adjudged GUILTY of suspension of hospital staff privileges as charged in Count One of the Administrative Complaint;
- 2. That the Respondent, Gregory Keith Parker, M.D., is adjudged GUILTY of inability to practice medicine with reasonable skill and safety to patients as charged in Count Two of the Administrative Complaint;
- 3. That the Respondent, Gregory Keith Parker, M.D., is adjudged GUILTY of unprofessional conduct as charged in Count Three of the Administrative Complaint;
- 4. That the Respondent, Gregory Keith Parker, M.D., is adjudged GUILTY of unprofessional conduct as charged in Count Four of the Administrative Complaint;
- 5. That, separately and severally for all of Counts One through Four, Respondent's license to practice medicine in the State of Alabama is **REVOKED**;
- 6. That it is the present sense of the Commission that any application for reinstatement of Respondent's license to practice medicine pursuant to Ala. Code § 34-24-337(e)-(j) is not likely to be granted unless and until Respondent

shall have submitted to a comprehensive evaluation of his fitness to practice medicine at ______, or at another similar facility approved in advance by the Commission, and the evaluators shall have found Respondent fit to practice medicine, subject to stated conditions;

- 7. That no administrative fines are assessed in this matter; and
- 8. That within 30 days of this order, the Board shall file its bill of costs as prescribed in Ala. Admin. Code r. 545-X-3-.08(10)(b), and Respondent shall file any objections to the cost bill within 10 days thereafter, as prescribed in Ala. Admin. Code r. 545-X-3-.08(10)(c). The Commission reserves the issue of imposition of costs until after full consideration of the Board's cost bill and Respondent's objections, and this reservation does not affect the finality of this order. See Ala. Admin. Code r. 545-X-3-.08(10)(e).
