MINUTES

Public Minutes of November 13, 2025 The Credentials Committee recommended that the Public Minutes of November 13, 2025, be approved. The motion was adopted without objection.

IMLCC 2025 Annual Report The Credentials Committee recommended that the Interstate Medical Licensure Compact Commission 2025 Annual Report be received as information. By unanimous consent the report was received as information.

Joint Resolution on Joint Committee of Pharmacy Collaborative Practice The Credentials Committee recommended adoption of the Joint Resolution of the Board of Medical Examiners

and Board of Pharmacy which negates the requirement for a 4th quarter meeting of the Committee on Pharmacy Collaborative Practice. The motion was adopted without objection.

FSMB Call for Comments: Legislative Developments for Unmatched Medical Graduates in the United States The Credentials Committee recommended that the Federation of State Medical Boards' Call for Comments on the draft report, *Legislative Developments for Unmatched Medical Graduates in the United States*, be received as information. By unanimous consent the report was received as information.

National Association of Boards of Pharmacy Request The Credentials Committee recommended the Board opine that, for the preemptive prescribing of antibiotics and other medications for potential emergency and non-emergency situations, the physician and patient must have an established physician/patient relationship; if prescribing by telehealth to a patient in Alabama, the physician must be licensed in Alabama and must meet all requirements of the telehealth statute; the completion of an online questionnaire is not considered the establishment of a physician/patient relationship; no multi-person/family prescriptions - each person to whom a prescription is written must be examined, in-person or via telehealth, by the physician; and prescriptions must be for an appropriate dose and quantity, not in excessive quantities for stockpiling. The motion was adopted without objection.

National Practitioner Alliance of Alabama (NPAA) Request The Credentials Committee recommended that staff communicate with the Medical Association's Education Department to discuss options for priority enrollment for anyone applying for an initial Qualified Alabama Controlled Substances Certificate (QACSC); options for virtual live and/or on-demand courses;

and to consider ways that individuals renewing their QACSC can be encouraged to complete virtual courses from the Board's approved list to meet the renewal requirement.

The Credentials Committee further recommended discussing with the Education Department the development and implementation of a post-course exam to evaluate attendees who must answer at least 80% of the questions correctly to receive course credit. The motion was adopted without objection.

Request to Amend Postgraduate Education Requirement for Full License The Credentials Committee recommended introducing legislation to create an alternative pathway for full licensure for licensees who hold a visiting, distinguished, or specialty professorship license pursuant to Ala. Code § 34-24-75(a). The Committee recommended that, in lieu of the postgraduate education requirement, the licensee must be in good standing with the Board, should have served as a professor in an Alabama medical college for a minimum of five years, and be ABMS or AOA board certified in addition to all other full licensure requirements. Each applicant should be presented to the Board for approval. The motion was adopted without objection.

Wellness Committee Appointment Declinations The Credentials Committee recommendation from the November meeting to accept the appointment declinations is deferred for discussion by the full Board.

After discussion by the full Board, a motion was made by Gregory W. Ayers, M.D., and seconded by Jane A. Weida, M.D., to accept the declinations of Tarak Vasavada, M.D., Mamie McLean, M.D., and Heather Neighbors, PA-C, of their appointments to the Wellness Committee. The motion was adopted without objection.




