2020 License & Registration Renewals

- All licenses and registrations (excluding P.A. registration agreements) are renewed annually.

- Online renewal requires last name and last five digits of SSN.

- You will first see a demographics page. Confirm your address, telephone number(s), email address, etc. After completing the demographics, proceed to renewing your license and registration(s).

- Online renewal site will open 10/01/19.

- Online renewal site: www.albrenewals.org

- **IMPORTANT:** Practitioners are required to complete renewal applications. Delegation of this responsibility could result in disciplinary action should fraudulent information be inadvertently submitted to the Board or Commission.

- Renew medical license first. If you have an ACSC, office based surgery or pain management registration, return to the home page to renew. A receipt can be printed upon completion of all renewals.

M.D./D.O. LICENSES

- Expire Dec. 31
- \$300 license renewal fee
- Grace period Jan. 1 – Jan. 31 (\$100 late fee added)

ACSC REGISTRATIONS (DEA AND PDMP REGISTRATIONS REQUIRED)

- Expire Dec. 31 (if not renewed, may not write c.s. after this date)
- \$150 renewal fee
- NO grace period

COLLABORATIVE PRACTICE (CP) REGISTRATIONS

- There is NO RENEWAL REQUIRED for collaborative practice (CP) agreements
- Termination of CP agreements may be completed during license renewal; however, that is the responsibility of the physician, and those terminations are FINAL

- The physician may make changes to the hours worked by CRNP/CNM; however, these hours must not exceed 160 hours per week

- Physician may also terminate a CP registration at www.albme.org/terminationform.html.

PAIN MANAGEMENT (PM) REGISTRATIONS

- Expire Dec. 31
- \$100 first location
- No charge for additional locations
- NO grace period

OFFICE BASED SURGERY (OBS) REGISTRATION

All physicians who answer yes to the OBS question on the annual renewal are required to complete the OBS Registration. The question asks if you perform any office based surgery/procedure outside a hospital or outpatient facility which requires moderate or deep sedation or general anesthesia; liposuction with tumescent infiltration is used; or any procedure in which Propofol is administered, given or used.

- The OBS question appears in the Board Certification section of the renewal.

- Access to the OBS Registration appears in the License Information section of the renewals home page.

- OBS Registration must be completed before January 31, 2019. Failure to register if you answered yes could result in action against your license.

CME REQUIREMENT FOR PHYSICIANS AND PHYSICIAN ASSISTANTS

Twenty-five (25) *AMA PRA Category 1 Credits™* or equivalent are required annually (calendar year). Credits must be earned Jan. 1 – Dec. 31 of each year. Licensees are responsible for reading and being familiar with Board Rules concerning CME.

NEW: ACSC holders are required to obtain two (2) *AMA PRA Category 1 Credits™* every two years in the area of controlled substances prescribing.

PHYSICIAN ASSISTANT RENEWALS

Renew license first. If you have a QACSC and/or an LPSP, return to the home page to renew them. The QACSC must be renewed before the LPSP can be renewed. A receipt can be printed upon completion of all renewals.

P.A. /A.A. LICENSES

- Expire Dec. 31
- \$100 renewal fee
- NO grace period

Note: P.A. Registration Agreements do not have to be renewed.

- Expires Dec. 31
- \$60 renewal fee
- NO grace period.

P.A. LPSP

- Expires Dec. 31 (if not renewed, may not write cIIs after this date)
- \$10 renewal fee
- NO grace period

** If the supervising physician has not renewed his/her medical license and ACSC by Dec. 31, 2019, the QACSC/LPSP will become inactive and no refund will be given.*

Important: Before renewing a QACSC/LPSP, applicant must earn 4 AMA PRA Category 1 Credits™ in prescribing controlled drugs every two years after the initial 12-hour Prescribing and Pharmacology course is taken.

CRNP/CNM QACSC/LPSP RENEWALS*

The QACSC must be renewed before the LPSP can be renewed. A receipt can be printed upon completion of all renewals.

QACSC (DEA AND PDMP REGISTRATIONS REQUIRED FOR RENEWAL)

- Expires Dec. 31
- \$60.00 renewal fee
- NO grace period

LPSP

- Expires Dec. 31
- \$10.00 renewal fee
- NO grace period

** If the collaborating physician has not renewed his/her medical license, ACSC and collaborative agreement by Dec. 31, 2019, the QACSC/LPSP will become inactive and no refund will be given. Collaborating physicians can renew online at www.alrenewals.org.*

Important: Before renewing a QACSC/LPSP, applicant must earn 4 AMA PRA Category 1 Credits™ in prescribing controlled drugs every two years after the initial 12-hour Prescribing and Pharmacology course is taken.

NOTICE TO LIMITED LICENSE/RETIRED SENIOR VOLUNTEER LICENSE HOLDERS

• Ala. Code §§ 34-24-75 and 34-24-75.1 require that a physician holding a Limited License or a Retired Senior Volunteer (RSV) license complete renewal applications for both the Limited or RSV Certificate of Qualification (COQ) and the Limited or RSV license.

• A Limited or RSV COQ renewal application must be submitted to and approved by the Board before a Limited or RSV license renewal can be completed.

• The COQ renewal application submission deadline is October 16, 2019 in order to be eligible for license renewal. The final meeting of the Board for 2019 is December 11, 2019. No limited COQ renewal applications will be accepted after December 9, 2019.

• To obtain the COQ renewal application, please contact the Dean, Program Director or Chief Medical Officer of the program or facility where you are a participant. Programs have been provided with the proper forms.

ATTENTION LAWFUL ALIENS/FOREIGN NATIONAL LICENSEES

All lawful aliens/foreign national licensees practicing in this state are required to submit yearly a Declaration of Lawful Presence form with proof of legal presence as a non-permanent alien. This information must be received and processed through SAVE in order to renew licenses for 2019. The online renewal program will not allow any license to be renewed until legal presence documentation has been received and approved by SAVE. Likewise, manual renewals will not be processed without proper documentation.

ALBME'S SOCIAL MEDIA GUIDELINES

Social media and electronic communications with patients continue to present many dangers for the modern physician. Maintaining the ethical and professional standards required to practice medicine in this day and age is increasingly difficult in an ever evolving social and digital landscape.

Questions you should ask yourself before posting anything on social media:

1. Would I say this in front of a patient if I were face-to-face?
2. Would I want my own physician to post something like this?
3. Do I want to explain this to the Alabama State Board of Medical Examiners?



The American Medical Association (AMA) and the Federation of State Medical Boards (FSMB) have issued new guidelines to assist physicians in successfully utilizing the benefits of social media and electronic communications while minimizing the risks.

The AMA Code of Medical Ethics Opinion 2.3.2[1] specifically addresses professionalism in the use of social media. The AMA's seven

In April 2019, the FSMB updated its Social Media and Electronic Communications[2] policy.

Regardless of medium or platform, professionalism and the code of medical ethics always apply in regard to a physician's actions and communications.

Does your practice prescribe Gabapentin?

Starting Nov. 18th Gabapentin will be a Schedule V Drug.

All physicians prescribing Gabapentin must possess a DEA registration and an Alabama Controlled Substance Certificate (ACSC)

ACSC holders are required to:

- Be registered to query the Physician Drug Monitoring Program (PDMP)
- Obtain two AMA PRA Category 1TM credits or equivalent (Cat. 1-A, prescribed hours, cognates) every two years in the areas of:
 - Controlled substance prescribing practices
 - Recognizing signs of the abuse or misuse of controlled substances, or
 - Controlled substance prescribing for chronic pain management
- Utilize risk and abuse mitigation strategies as appropriate

All physician assistants, certified registered nurse practitioners, and certified nurse midwives prescribing Gabapentin must possess a DEA registration and a Qualified Alabama Controlled Substance Certificate (QACSC)

QACSC holders are required to:

- Have at least one year of work history in Alabama in a registration or collaborative agreement
- Obtain 12 AMA PRA Category 1TM credits within 12 months prior to making QACSC application
- Obtain four AMA PRA Category 1TM credits every two years
- Maintain an active registration or collaborative agreement with a physician
- Be registered to query the PDMP
- Utilize risk and abuse mitigation strategies as appropriate

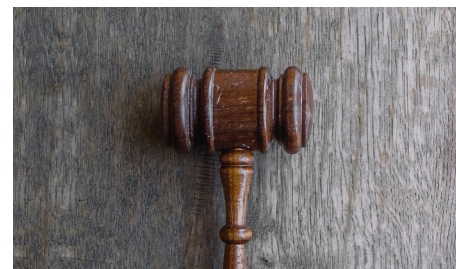

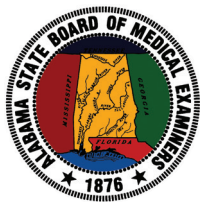
